#### 7. Report of the Right Eminent Grand Commander

SK John H. Austin KCT



Most Worshipful Grand Master Spicer, Right Worshipful Deputy Grand Master Watson, Department Commander Steele, Honored guests from other jurisdictions, Sir Knights all;

Welcome to the City and County of Frederick Maryland. This is my home, and a place of much history. Each of you who registered should have received a packet from the

local Visitors center which will inform you of the places of interest in the area. I hope this will encourage you to come back and spend some time in this most welcoming City and enjoy the activities and history available to you within a very short travel from where we sit today.

We have introduced to you, many of our guests and Past Grand Officers already, however I want to take a moment to remark upon the conviviality as well as friendships that have developed through the years with these men and to the organizations that they represent. For the past 2 years and more, my wife Kandi and I have crisscrossed the State and traveled to several others to become guests of every possible Masonic and Community organization that you can imagine. Not to mention the number of times that I have traveled to the Constituent Commanderies of Maryland to help, aid, and assist in the work of the Knights Templar.

In every case, my wife and I were treated with great kindness and hearty welcomes and with respect and regard to the office of REGC as well as to its holder of the moment.

This includes hundreds of State and District conclaves, Grand Lodge and constituent lodge events, Eastern Star and Youth Annuals – Jobs Daughters, DeMolay and Rainbow girls, SOOB, York Rite Grand Bodies and appendant and concordant organizations such as York Rite College, AMD, Knight Masons, Red Cross of Constantine, Scottish Rite, Shrine and other Masonic and non-masonic institutions. I have learned much about our Great Masonic Family, that I was not aware of, and come to relish the variety, as well as the energy and support of the families of our membership. The mothers and fathers of these young people, and the officers that support them, perform some heroic feats of organization and creativity.

Our, out of State Masonic organizations, are nearly overwhelming in their ability to show hospitality and courtesy. On many occasions, members of the Grand Commandery line were able to accompany me, and they too received the gracious welcomes and interesting variety of customs, ceremonies and formalities that were accorded us. I believe we have all come away with new knowledge and friendships that will last for many years.

Thank you all for coming to celebrate and witness the changing of the Guard that is about to take place. Will you all please join me in acknowledging those visiting dignitaries, and the officers present of the various Masonic local organizations, as well as those not able to be present from Maryland Commanderies and Grand Lodge, by a warm round of applause and thanks.

I have mentioned in my remarks already the Past Grand Commanders present and those unable to make it today. Prior to putting together my plan 2 years ago, I called or met with each of my living predecessors in this job. Seeking their wisdom and guidance, I crafted my administration based on not

only the ongoing programs instituted by my immediate predecessors, Art Hebbeler, Spyros Treklas, Charles Warns II, but also suggestions from each of THEIR predecessors. Additionally, we were just coming off the beginning of what remains to be a very disjointing Pandemic which slowed down Freemasonry and essentially shut down Templary for all intents and purposes as the Grand Encampment forbid us for a long while to meet in person.

I focused my plan on 6 essentials: Membership, KT Ritual and Training, Education Foundation Scholarships, KTEF, Religious Observance, Uniform and Wardrobe.

One member from each commandery was assigned to be a liaison with Grand Commandery officers to work on each of these items. I would say it was a mixed bag of results. And we've still been pursuing this with our individual Commanderies, in personal visits to each.

Membership is about even with some Commanderies doing better than others. We have 2 commandries preparing to merge with a final report from Jurisprudence and a vote to proceed here later this afternoon, 2 commanderies are faltering and we are a bit worried about the continued ability of one of them to remain in operation, and the remaining 7 holding their own or growing.

Ritual was severely hampered by the passing of our Grand Inspector General REPGC Randy Disney, God bless him. His banner has been taken up now by the wizened and oft used hands and heart of REPGC Richard Naegele. SK Richard will be a terrific teacher and knows the ropes when it comes to our ceremonial openings and Orders.

We have continued a KT training program with REPGC Charles E. Warns II and his team of traveling training Knights. I have had the opportunity to sit in on 3 of these classes which are several hours long and very thorough in the discussions and instructions, on just what it takes to understand the ins and outs of a Knights Templar conclave. Every time I see the program, I learn more about our respected and impressive ritual and tenets of the institution of Knights Templar. When finished, the team conveys to those in attendance, how the proper manner of conferring our 3 Ritual Orders lends majestic dignity and grandeur to any asylum where we practice our craft.

Work on a new KT Handbook for Maryland moves along and should be printed next year. Our committee has met several times and I believe we are nearing the final cut on what will become not only a written and printed document, but also the basis for a vibrant new interactive website which is also a goal.

KTEF is successful and last year we were certified as 100% Life Sponsors. Now we are working on keeping it that way. You will hear shortly of a recent visit to NIH and the Johns Hopkins to celebrate 2 KTEF Starter Grants.

Our Education Foundation Scholarships have increased in participation the past 2 years and checks have recently gone out to a number of applicants. Chairman REPGC Art Hebbeler, has enhanced the selection process and greatly increased progress and new methods of selection prepared for the 21<sup>st</sup> century. There is a plan in the works to invest in a strategic system of gauging the worthiness and need of our applicants.

The Religious Observances have really had a kick with our Grand Prelate Charles Beckhardt leading the way with gentle reminders of our Christian calendar, preparing programs, and with active participation in helping to attend and instruct in Commanderies. Last year we had the best participation in many years from our constituent Commandries, and families in Christian Observances.

A new program offered by the Grand Encampment offers those of you who have a calling in Christian support of our members and the community at large. You may take a course in helping others through difficult periods. We are fortunate to have 3 new Commissioned Chaplains, celebrated just last month at the Department Conference in Crystal City. More are on the way with this new and highly regarded program.

We had one minister from the Eastern Shore travel on the Holyland Pilgrimage this past season. I have met her and from what I have learned, her experience was top notch and not to be forgotten. I was able to hear and see the report from a minister that Jacques DeMolay Commandery, right here in Frederick, gave about a month ago and his enthusiasm for the program was contagious.

Our Uniform and Wardrobe program is doing OK. We have programs in place to subsidize the purchase of uniforms and the accountrements that are required to be worn on them. We have a Sword Program, offering a new sword for any knight the secures a uniform and chapeau or cap. Our civilian wardrobe program helps to subsidize the costs of outfitting the uniform once purchased.

Civilian garb is being purchased by our members in record numbers and we have recently had a new batch of Maryland polos printed to refill the stores. You will find these and other items for sale at the registration area and in the Hospitality Suite.

By enabling our members more readily to acquire a uniform and to dress in civilian garb with Knights Templar logos, we feel that an esprit de corps is being developed to strengthen the unity and pride of membership. Not to mention that the sharply dressed Knight, in public, such as at Parades and in Lodge flag presentations, as well as a man in the striking garb available with our caps, shirts and jackets, will often be questioned about the organization. Keep your elevator speech on Templary handy if you are so garbed.

The public visibility of our organization is always important and attendance at Parades, Religious gatherings, Masonic events, and Community charitable organizations is vital to the image and health of our Knights Templar organizations. Your Grand Commandery visibility and personal presence is important. Last year and in previous years for instance we participated in New Market parade, in Baltimore at the Mayor's Parade which featured members of our Grand Commandery in full Crusade era costume and chainmail on horseback- Stunning to see the reactions of the crowd watching from the curbs and sidewalks as they rode past.

The Alexandria Virginia Parade celebrating the 100<sup>th</sup> anniversary and reenactment of the Cornerstone laying of the George Washington Masonic National Memorial along with thousands of Masons, as well as participating in a public march in Williamsburg Virginia Bicentennial with a couple of hundred others in full uniform, and as always the Westminster Memorial Day parade with Carroll Commandery and Grand Commandery attendance in the longest running annual event of its kind in America.

Finances- You will hear a report on the health of our well monitored accounts from our Eminent Grand Treasurer SK Randy Watson and be assured that the funds of the Grand Commandery are in good shape

and the Finance Committee headed by your current VEDGC and GC elect Bradley Andrukitis are attentive to what the Grand Commandery does with your contributions and those of our many members that have created this legacy.

Youth- The 3 youth groups here in Maryland are astounding. Your Grand Commandery continues to support them and as I mentioned earlier, Kandi and I have had a first hand opportunity to see the wonderful work that these young folks do. Along with the amazing support and assistance of loving parents and doting leadership of many masonic organizations they are traveling a wondrous road of fun and enlightenment. Kudos to those that in the past have set these engaging, educational and honorable organizations in motion and keep them thriving.

Jurisprudence- I have had many occasions to consult the Jurisprudence Committee on an article of difficulty with a member or one of our Constitutional requirements. The committee and especially chairman, REPGC John Rafine has always cheerfully and thoroughly walked me through the maze of language and nuances of the law of our Maryland rules as well as delving into the more voluminous language of the Grand Encampment. SK John, I cannot thank you enough for your diligence, time and brilliant analysis provided me.

The future of your Grand Commandery of Maryland is assured. At the semi-annual in May, officers were chosen of such high caliber and capability that the governance of the Templars of Maryland is not in question. The line of officers to be installed here later today is a diverse and able group of men and Christian Masons.

My partner in Business Robert Frost (no kidding- that was his name and believe it or not his father's name was Jack), many years ago, made this statement. 'Organization and Morale makes a business tick.' I have lived my working life by these principles. To those words I would add one more thing and make it the working motto of the leadership of Knights Templars. That word is 'Commitment'. When your members are being considered for office, The one thing that makes sense to have, is a desire to make the long haul run. To do that one must be Committed. The Time and Energy, travel, expense, communication skills, and up and down swings of success and failure are ever present and require much of a man and Mason.

I want to recognize the contributions of 2 individuals. REPGC Randy Disney passed on to those hallowed gates of heaven not long ago. Randy was a wonderful man, a teacher, a disciple of Masonic studies and an excellent Ritualist with a mind like a sponge and the ability to convey a thought like that of a trained actor. He was low key, respectful and respected within Masonry and especially among those of us in the York Rite Community. When I asked him if he would take over the position of GIG with the previous occupant -Our Grand Master Fred Spicer moving on, he agreed with one caveat. He would not take the job without being able to travel the State and teach Ritual, which has been lacking from the long break and participation at a low level. This, I responded to wholeheartedly, with positive and cheerful agreement. Randy wrote, and we posted, a manifesto of sorts for his plans and offer to visit repeatedly the Commanderies of the State of Maryland. We had just begun traveling the State together to lay out his vision, when he took ill and had to work on his health. Randy had recovered from serious health issues and unfortunately had a relapse and never was able to recover. He left us with empty hearts and unfulfilled wishes. We all miss him Greatly. I know that I do. His Brother Jeff is here today to honor him.

I don't know how he managed to do it, but Jeff presided over a very moving memorial service for his brother a few months ago. Jeff would you please rise and be recognized.

When our Eminent Grand Recorder Emeritus SK Kris Brown took ill, we were floundering in the important administrative aspects of the organization. Out of the Blue one day, I received a call from SK Vernon with an offer that I was shocked to hear. Vernon knew that the plans of the Commandery and my term were in jeopardy and offered to step in for the short term until such time as Kris recovered enough to resume his duties. I quickly accepted and we made him Asst. Grand Recorder. It did not take long for Vernon to begin to make a difference and his diligence, research, and contacts with the Grand Encampment with guidance from Kris, saved the day for Templary in Maryland. It would take me a long time to tell you all the things that Vernon has done for Templary and for me personally. Many hours on the phone and emails with detailed accounts of the running of your Grand Commandery have paid off with a wonderful climate of trust and an association for us that has been extraordinary and uplifting. I have told Vernon that his calling may be with the clergy, as he is passionate, compassionate, and helpful in every way. I don't know what else may come of this. But I know one thing. I have a friend for life here. Thank you, Vernon, for all you have done for Templary and for me.

I further wish to thank Department Commander James Steele for his guidance, friendship and help along the way. You may not know this, but one of these jobs of leadership are fraught with twists and turns of unexpected nature and often complexity. Report to the Department Conference 2023
Mid Atlantic Department Conference 2023- Comments from REGC of Maryland

My 2 year term of office comes to a close next month. It has been an honor to represent the State of Maryland as its Grand Commander and an honor to work closely with the Grand Encampment, and see the workings of the machinery up close. I have come to admire the Leadership of our illustrious organization and gained some insights into our Christian Order that heretofore, I was unaware of.

My partner in Business Robert Frost, many years ago, made this statement. 'Organization and Morale makes a business tick.' I have lived my working life by these principles. To those words I would add one more thing and make it the working motto of the leadership of Knights Templars. That word is 'Commitment'. When your members are being considered for office, The one thing that makes sense to have, is a desire to make the long haul run. To do that one must be Committed. The Time and Energy, travel, expense, communication skills, and up and down swings of success and failure are ever present and require much of a man and Mason.

When I began my term, Covid was, and still is, a factor in all of our Commanderies. We still have not had the return of many of our members who found other things to do when the Pandemic took away our regular scheduled Order of work. Who can blame them? It was a huge factor. To try to reinvigorate Maryland Commanderies, 6 things were stressed that I felt needed to be pursued to give assistance and life to our commanderies along with information needed to understand our work as Knights Templar.

Those 6 are: Membership, KT Ritual and training, KTEF, Religious Observances, Education foundation scholarships, Uniforms and Wardrobe. One member from each commandery was assigned to be a liason with Grand Commandery officers to work on each of these items. I would say it was a mixed bag of results. We're still pursuing this with individual Commanderies in personal visits to each.

Membership is about even with some Commanderies doing better than others. We have 2 commandries preparing to merge, 2 commanderies faltering and the remaining 7 holding their own or growing.

Ritual was severely hampered by the passing of our Grand Inspector General REPGC Randy Disney, God bless him. We have continued a KT training program with REPGC Charles E. Warns and his team of traveling training Knights. Work on a new KT Handbook for Maryland moves along and should be printed next year.

KTEF is successful and last year we were certified as 100% Life Sponsors. Now we are working on keeping it that way. Next week a party of Sir Knights will head to NIH and the Johns Hopkins to celebrate 2 KTEF Starter Grants.

Our Education Foundation Scholarships have increased in participation the past 2 years and checks have recently gone out to a number of applicants.

Our Religious Observances have really had a kick with our Grand Prelate Charles Beckhardt leading the way with gentle reminders of our Christian calendar, preparing programs and with active participation in helping to attend and instruct in Commanderies. Last year we had the best participation in many years from our constituent Commandries and families in Christian services. We also have new Commissioned Chaplains, celebrated just last night at the dinner here. More are on the way with this new and highly regarded program.

Our Uniform and Wardrobe program is doing ok. We have programs in place to subsidize the purchase of uniforms and the accoutrements that are required to be worn on them. We have a Sword Program, offering a new sword for any knight the secures a uniform and chapeau or cap.

Civilian garb is being purchased by our members in record numbers and we have recently had a new batch of Maryland polos printed to refill the stores.

I want to thank the Officers of the Grand Line for their hard work this year and especially single out our Grand Recorder SK Vernon Huebschman for really working closely with me this past year and bringing the entire level of communication with Commanderies and Grand Encampment, as well as Templar administration to a fine point.

Our VEDGC Brad Andrukitis has been involved with all the decisions and plans for the past 2 years and heads our finance committee and several of the other committees which are instrumental to our success. He is well prepared to seamlessly take on the duties of the office.

I have made many friends among you the past few years and it's been a pleasure and personally a humbling and welcome experience.

#### 9. Report of the Grand Treasurer

#### SK Randall L. Watson KCT

This Report covers the period from November 1, 2022 to October 21, 2023 regarding the 2023 income and expenses. Income thus far totals \$23,307.01; expenses total \$40,842.28, so we've drawn \$17,535.27 out of the Operating Fund.

As discussed at the Semi-Annual in May, it was not necessary to transfer any of the allowable amounts from the Endowment Fund this year. The cumulative balance of transfers deferred from the years ending March 2017 through March 2023 is \$141,111.43 (correcting the \$122,399.29 shown on the May 2023 Report as submitted).

The balance in the operating account with Morgan Stanley as of September 30, 2022 was \$304,707.45; as of September 30, 2023 it is \$280,600.03; a decrease of about \$24k (-7.9%).

The balance in the Endowment Fund with Morgan Stanley as of September 30, 2022 was \$724,036.63; as of September 30, 2023 it is \$831,092.47; an increase of about \$107k (+14.8%).

The balance in the Educational Foundation with Morgan Stanley as of September 30, 2022 was \$605,753.53; as of September 30, 2023 it is \$668,846.37; an increase of about \$63k (10.4%). However, there are scholarship checks of \$12,000 that weren't cashed as of September 30<sup>th</sup>.

#### 15. Report on the Knight Templar Education Foundation

#### REGC

Your Knights Templar Educational Foundation Committee is pleased to report that 2022-2023 was a successful year. We had \$18,175.00 available for award this year, but only had 8 applicants, and of those, only two were 100%. There were three others that were missing one or two references, and the rest had significant missing components. We made the following awards:

Total Scholarships: \$12,000

- 1. Aisa Wrights \$5,000 (Senior college year)
- 2. Alexa Wiker- \$5,000 (Rising college freshman)
- 3. Ashby Remley- \$1,000
- 4. Ava Becnel- \$500
- 5. Natalie Kinnear- \$ 500

In accordance with KTEdF guidelines, we can set aside funds for administrative costs, with a general guide (not a hard limit) equal to the annual CPI. We have not had any administrative expenses, except the Grand Encampment filing fees, for many years, and have retained several thousands of dollars over that time in undistributed scholarship funds. With that in mind, your Committee plans to set aside funds from 2023 and 2024 to assist in building an automated application process for 2023-2024 and the future, and we are seeking professional web development assistance with this project.

As required by the KTEdF policies, we present the following budget for 2023-2024 for approval by the Grand Commandery in conclave:

This committee is pleased to provide the requested information as we continue our efforts to increase our membership of Knights Templar in Maryland. The membership committee has continued to be active since our Annual Conclave. As the Grand Commandery Officers have traveled with the REGC around the state we have had the opportunity to hear from the membership chairman from most of our commanderies as to their membership status.

As we strive to increase our membership it is important to have an accurate picture of where we currently stand. Our Eminent Grand Recorder SK Vernon Huebschman has played a key role assisting with this committee and the MMS.

As of May 8, 2023, we had 913 Sir Knights on the membership roster.

As of October 16, 2023, we have 917.

We had (15) Sir Knights who have passed away.

We had (22) who were Knighted, (3) who affiliated, (3) who demitted, (3) who were suspended, (0) who were reinstated, a net gain of (4).

We have one Commandery that is having difficulty with attendance. This Commandery has been assisted by Sir Knights from another Commandery and during the last few months they have continued a merger of the two, and if all goes well, will benefit both. We are encouraged by this development. This merger is very close to being finalized.

Public awareness and a public presence in our local communities is imperative to our membership. As Knights Templar we have a responsibility to assist those in need, now more than ever.

Some of the activities that constituent commanderies engaged in community involvement and awareness included presenting charitable contributions to various organizations throughout their area to assist with healthcare, homelessness, food assistance, and youth groups.

In December, The Grand Commandery will again participate in the Baltimore Mayor's Parade, a wonderful opportunity to be seen wearing our uniforms in a public setting. We will even have several Sir Knights on horseback.
