Proposed by G. Andrew Martinez, GHP

Proposed Changes: (in Bold and underlined)

Article 6, Section 4: The Grand Lecturer <u>and/or Deputy Grand Lecturer</u> shall visit all the Subordinate Chapters in the jurisdiction at least once every year, and impart to them such instructions, as they may need. The Grand Lecturer <u>and/or Deputy Grand Lecturer</u> shall report at each Annual Convocation the condition of the several Chapters. The Grand Lecturer <u>and Deputy Grand Lecturers</u> shall be paid for <u>their services</u> from the funds of the Grand Chapter, <u>his</u> the actual expenses incurred, and such sum as may be fixed from time to time by resolution of the Grand Chapter.

Article XII, Section 5, (b), 1, b

He must be certified by the Grand Lecturer or Deputy Grand Lecturer as meeting the current standards for Ritual proficiency.

Article XII, Section 5, (b), 3, a

Attend the Annual Law School conducted by the Grand Lecturer or Deputy Grand Lecturer.

<u>Justification:</u> This will hopefully relieve some of the pressure on the GL position and add some flexibility in covering all of the GL's responsibilities should be be unavailable.

7. GRAND COMMANDER'S REPORT

Grand Encampment Officers, Right Eminent Past Grand Commanders, Distinguished Guests, and Sir Knights All,

It is my great pleasure to stand before you this afternoon and present my report as Grand Commander of Knights Templar of Maryland.

I am grateful for all our Grand Commandery Officers and Committee Members who have worked diligently since taking office at our 2023 Sessions. I want to thank each of them for their efforts.

They have been busy assisting with taking care of their committees' various duties.

Over the past year, I have had the honor of attending many events within and outside the state representing the Grand Commandery of Maryland.

I had the honor of being REGC during the 150th Anniversary Celebration of my Commandery, Palestine Commandery No. 7. On November 27th, they held a Festive Board to celebrate 150 years of Templary in our state capital of Annapolis. It was a wonderful evening beginning with DeMolay from across the state exemplifying the DeMolay Degree. This exemplification was followed by the Festive Board with many toasts and tributes to commemorate this historic event.

In December, Christmas Observances brought us to the Grand Lodge where Maryland Commandery No. 1 and Monumental Crusade Commandery No. 3 held their annual joint event on December 17th and to Westminster on December 22nd, where Carroll Beauceant Commandery No. 8 held their first Observance since their merger. Both celebrations were well attended and enjoyed, together with family, friends, and our fellow Sir Knights.

On Sunday, December 17th, prior to the Christmas Observance at Grand Lodge, I had the pleasure to assist our Grand Prelate, Charles Beckhardt, with our Annual York Rite Religious Service for the residents at Bonnie Blink as the Grand Commandery was the host this year. Unfortunately, due to a COVID outbreak at the homes, the service was conducted on closed-circuit television to the residents in their rooms. The Grand Prelate delivered a wonderful service, and I hope that his message resonated with all the residents as much as it did with me.

On Saturday, December 16th, our Sir Knights assisted with the installation of Officers of the Westminster Assembly #245 Social Order of the Beauceant. In June, we traveled to Westminster to attend their 50th Anniversary Celebration. We are excited to be on the brink of seeing a new SOOB Assembly opened in Cockeysville. I want to thank these ladies for all their assistance throughout the year.

On January 6th, Lady Christine and I had the pleasure to attend Twelfth Night which was hosted by Monumental Crusade Commandery No. 3. The Gothic Room at Grand Lodge is the perfect setting for this event. Thank you to VEDGC Scott Lapp and Lady Marcy for a wonderful time. The food and entertainment were very enjoyable. It was nice to have in attendance SK Mark Button, REGC of Delaware (at the time), and his wife, Heike.

The Grand Commandery Officers have had the honor and pleasure to install the officers of Maryland, Monumental Crusade, Montgomery, Palestine and Chesapeake Commanderies. I believe our participation at these installations helped to boost attendance and to make the occasions special for the incoming officers.

Commanderies have been conferring degrees and working hard to make sure that our Knights are progressing through them as quickly as possible. It is nice to see commanderies working together when necessary to make this happen.

REPGC and GIG Richard Naegele continues to travel around the state conducting inspections and making sure that our commanderies are staying proficient in ritual as well as sword drills. He also held several scheduled training sessions across the state.

Excellent Grand Prelate Beckhardt has done an excellent job in making sure our commanderies are conducting religious services which is so important for a Christian organization. Participation in Christmas and Ascension Services have increased across the state. We attended our Annual Easter Observance at the GWMNM. Maryland was well represented. This is always a great way to celebrate Easter morning. Our hope is that this will move back to an outdoor event next year.

The Grand Commandery of Maryland has been represented well in traveling to other jurisdictions. This year we have attended Grand Conclaves in Virginia, Pennsylvania, Delaware, the District of Columbia, North Carolina, and West Virginia.

If my schedule did not permit me to attend, REPGC John Austin, and/or others attended and brought greetings on behalf of the Grand Commandery of Maryland.

Last month, MADC Austin and I traveled to Gettysburg for the Grand Commandery of Pennsylvania's Annual Memorial Service.

Membership continues to be a concern in many organizations, including Knights Templary in Maryland. Membership committee chairman, SK Bradley Thomas has been working diligently with the commanderies to increase membership.

Our acting quartermaster, VEDGC Scott Lapp has been working with all of our commanderies to ensure our uniforms are standardized and meet the required regulations. He has a supply of many items which our recorders can order from him, or he can direct them in the right direction as to where they can purchase them.

Public awareness and a public presence in our local communities is imperative to our membership. Some of these activities that our constituent commanderies engaged in community involvement and awareness included presenting charitable contributions to various organizations throughout their area to assist with homelessness, food assistance, and youth groups. We participated in the Westminster Memorial Day Parade with some Sir Knights in Chainmail on Horseback which drew a lot of attention from the onlookers. We will also be participating in the Baltimore Mayors Parade in December. At our recent Harvest Home Day Event, the Grand Commandery along with the other York Rite Grand Bodies manned tables inside of the Grand Lodge where they sold various commandery items and provided information about Knights Templary. The beautiful Gothic Room was also open for tours by our Sir Knights.

The Knights Templar Eye Foundation and Education Foundation continue to do well. A few weeks ago, along with our KTEF Chairman, Gary Kennedy and our MADC John Austin, visited the Wilmer Eye Institute at Johns Hopkins University to present 3 \$90,000 grants to 3 very deserving doctors who continue to assist with alleviating blindness in children. We were able to attend at Wilmer and NIH last year and see the great works in research and the advancements that they are making. It was so rewarding to hear their stories and see their accomplishments.

This year we were fortunate to award 8 scholarships totaling \$23,000 on behalf of the Education Foundation to some very qualified students to assist in their continued education.

We continue to support our youth groups, including providing financial support and assisted with an Arch of Steel at the Rainbow Grand Assembly where Kaylee Wisnewski was installed as Grand Worthy Advisor.

I would like to thank the Right Eminent Past Grand Commanders who have guided me as necessary and were always willing and able to assist with any questions or concerns that I have had over the past several years.

Thank you to REGC-Elect Scott Lapp and the other Grand Commandery Officers, especially REPGC and MADC John Austin, EGR Vernon Huebschman, and EGT Randy Watson who have been so supportive of me and eagerly assisted me with whatever I needed and helped to promote Knights Templary around the state.

I would like to thank all of those who committed their time and efforts into making this weekend possible. From the planning stages to the execution, they have done a wonderful job.

And finally, I would like to thank my wife, Christine. She has assisted me behind the scenes, for the past several years in the Grand Commandery and especially this past year. I am very grateful to her.

8. Report of the Grand Recorder

Right Eminent Grand Commander

- A. Constituent Commandery Recorders are to be congratulated for their successful efforts to manage the business of their respective Commanderies. Several Recorders are new to the calling and are doing very well.
- B. Please update the MMS with each membership status event as they occur. This begins with posting in reception of a petition and continues through the conferral of each of the Orders. Major changes including Demits, Suspensions and Deaths must be posted immediately on determination or the reception of notification of such events. All updates must be posted before December 31st of each year.
- C. For most Maryland Commanderies, the IRS 990N are due to be filed immediately after January 1st of each year. As you attempt to file the IRS will inform you if you attempt to file this report before your anniversary date. This report takes approximately 15 minutes to complete but if you fail to file this report for three years it will cost you a minimum of \$600 to file for reinstatement of the Not-for Profit status with the IRS.
- D. AWARDS: Please note that several of the awards concerning the contributions of our Sir Knights in the local Commanderies are nominated from within the Commandery itself...not by the Grand Commandery Awards Committee, like the Distinguish Service Award and the Companion of the Temple.
- E. ANNUAL REPORTS & ASSESSMENT: are based on the data in the MMS as of December 31st of the preceding year. If a members has a change in status which is not recorder on time, you will be billed for his membership in the annual assessment. I follow the example of SK Kris Brown by sending out electronically the Annual Membership Reports for all the Chapter and a calculation of the annual assessments based on these reports. Each Commandery can see the status and assessments of all the other Commanderies for complete transparency.

REGC, I have enjoyed serving you during your tenure in office. You have been a firm and kind hand upon the tiller of our ship. Thank for your cooperation as we have labored together, and your forbearance

when my efforts have been lacking. I wish you well in the path you will be entering soon, joining those York Rite Masons who have gone on to serve in our Grand Lodge.

9. Report of the Grand Treasurer

SK Randall L. Watson KCT, Grand Treasurer

Treasurer's Report for 2023/2024 Annual Grand Conclave October 25, 2024

This Report covers the period from November 1, 2023 to October 21, 2024 regarding the 2024 income and expenses. Income thus far totals \$22,139.00; expenses total \$45,895.23, so we've drawn \$23,756.23 out of the Operating Fund. We have also prepaid out of the Operating Fund \$937.30 for challenge coins against the 2024-2025 budget.

We were over budget for the Mid-Atlantic Conference (expense code #19). We will recover the cost of a participant in the Commissioned Templar Chaplain Program from his Commandery.

As discussed at the Semi-Annual in May, it was not necessary to transfer any of the allowable amounts from the Endowment Fund this year. The cumulative balance of transfers deferred from the years ending March 2017 through March 2024 is \$163,208.88.

The balance in the operating account with Morgan Stanley as of September 30, 2023 was \$280,600.03; as of September 30, 2024 it is \$318,246.59; an increase of about \$38k (13.4%).

The balance in the Endowment Fund with Morgan Stanley as of September 30, 2023 was \$831,092.47; as of September 30, 2024 it is \$1,086,032.11; an increase of about \$255k (+30.7%).

The balance in the Educational Foundation with Morgan Stanley as of September 30, 2023 was \$668,846.37; as of September 30, 2024 it is \$848,487.51; an increase of about \$180k (26.9%). However, there are checks of \$22,000 that weren't cashed as of September 30th (\$1,000.00 for the annual Grand Encampment fee; \$5,000 for a replacement for a 2023 scholarship; and \$16,000 for 2024 scholarships).

20. GRAND INSPECTOR GENERAL'S REPORT

REGC Andrukitis,

This is probably the most difficult report I have had to write for the Grand Commandery. During my previous tenure in this position over ten years ago, I had noticed a marked increase in the ritual proficiency in the Grand Commandery. All but three Commanderies stood inspection and nine did a complete inspection. I'm sorry to report the three that did not stand no longer exist today.

This year only three were able to do the full requirements. I wish to thank the Commanderies that put forth the effort to do what they could for the inspections. From what I was able to do, I would like to present the following Commanderies with these awards:

James Primus Sword Manual Plaque – Monumental Crusade #3

Alfred Collins Full Form Opening – Palestine #7

Edward J. Warwick Trophy – Montgomery #13

Grand Inspector General's Award Banner – Chesapeake #10

These Commanderies are to be congratulated on the efforts they put forth.

During the summer we held two Schools of Instruction. I wish to thank Montgomery and Monumental Crusade for hosting them. We went over the signs, grips and words associated with all three Orders along with tactics for placing the flag. Those that participated said they learned something new and that is what matters.

When the requirements for ritual proficiency were modified to meet Grand Encampment's criteria for election, a noticeable decrease in ability to do the Orders has been noted. This lack of proficient ritualists in our state has led to a decrease in conferrals and thus new members. I am hoping we can turn this around.

Several years ago a program was instituted called the "Knights Templar Ritual Awards" and has three levels to attain – Pilgrim, Warrior and Knight. Currently I am unaware if many have pursued this program but do know that some Past Commanders were awarded Warrior status from their past proficiency. Also, it has been unclear who is to oversee the program and keep records, since none seems to exist.

I am proposing the following for the coming year and till such time as Commanderies are restrengthened to do their own ritual work.

- 1. Two teams be established for each of the Orders and to confer them at least twice each year in different parts of the State.
- 2. Inspections as they are currently held be suspended for at least two years. If Commandries want to do the sword drill for competition purposes that would be great.
- 3. The KT Ritual Award program be restarted under the direction of the Grand Inspector General.
- 4. All officers in each Commandery attain the status of Pilgrim by the end of the term.
- 5. The dais officers in each Commandery attain the status of Warrior by the end of two years.
- 6. Grand Commandery Officers should follow these same criteria for attainment.
- 7. At least two Sir Knights attain Knight status by the end of two years.
- 8. Recognition be given at Grand Session each year to all reaching each of the levels.

I hope this will make a difference in our work. As I was told many years ago by a Past Grand Commander and Department Commander – do something, do something different and do it now!

25. Quartermaster's Report

SK Scott G. Lapp, VEDGC

October 25th, 2024

REGC Andrukitis,

Our quartermaster's office has been primarily non-active over the 2023 and 2024 seasons due to many challenges concerning the business of the office. In June of 2024, I was given the keys to the storage for the Grand Quartermaster closet and assumed the role as Interim Grand Quartermaster. With your permission, I immediately started using what supply of stock I had been handed, and issued uniform items to Commanderies all over the state, in an effort to make up for lost time and get supplies to our Sir Knights.

The first step was to go to or virtually conduct uniform inspections. All but 3 Constituent Commanderies complied, and those remaining will be short listed to have inspections once my permanent replacement is named for the ensuing term. Once a list of needs were made by Commandery, I sent those items currently in stock to the respective Commanderies to be issued. Note, I as Grand Quartermaster took no individual orders, but instead issued all gear to the E.C. or Recorder of those Conclaves, and subsequently billed the Commanderies for those items. The Constituent Commanderies are at their discretion, able to pass the cost on to the Sir Knight, or absorb it as their cost instead. This also keeps from suffering a rash of errant off the cuff orders to the Grand Quartermaster, and allows for a checks and balances approach to paraphernalia that can be controlled by the E.C. It also serves as his approval for purchases made by that Commandery.

Second, having issued all I could, I placed several orders for out of stock and restock items, to finish the inspection items needed, and replenish stock for future use. All expenses should be covered by the payments received from the Constituent Commanderies. This is the phase we are in now. I will stay on a short time and assist the new Grand Quartermaster in transition, so he knows where we left off and where to pick up. Continuity is the goal here, with our Sir Knights seeing no lapse in support from this office, and the new Officer fully apprised of vendors, costs, and protocols to discharge his duties immediately and with full exertion.

Therefore, I would like to take the opportunity to remind our membership that the supply chain issues we experienced in the past are no longer a factor and the Grand Commandery will make uniform compliance a priority in the coming term. So I strongly urge all Commanderies to appoint a Constituent Quartermaster and expect him to work closely with the Grand Quartermaster to make this happen.

Lastly, I would like to remind the members that although normal chain of supply is from Commanderies only, that does not apply to cash sales of items (that must still only be worn if eligible by the Sir Knight) or for civilian attire and regalia. Hence we will have the quartermaster supply available for cash purchase in the hallway during the event at some point Friday or Saturday evening, depending on sales support staffing. Come and get that polo or car medallion you've been looking for, or see P.C. Rossmark about getting a fantastic looking Knights Templar Maryland automotive vanity plate.

On behalf of the Committee on Awards and Recognition, I am pleased to submit this brief report.

As awards will be presented at the Annual Conclave in October, there is nothing significant to report at this time. However, we offer the following information to all Commanderies:

- 1. The *Knight Templar Cross of Honor* (KTCH) must be voted upon in a Conclave of the Commandery, and the nomination form provided by the Grand Encampment, signed by the Commander and Recorder, and sent to the Grand Commander, not the Deputy of the College of Honors. Only one recipient may be selected by the Grand Commander each Templar year.
- 2. The Companion of the Temple (fee \$100.00) may be awarded to any non-Templar for service to the Order. Nominations may be submitted by any current holder of the Companion of the Temple or Knight Commander of the Temple. Nominations must be submitted in writing to the Deputy of the College of Honors at least 90 days before the desired award date, and should be in sufficient detail to describe the exceptional service made. There is no limit on the number of awards the Grand Commandery may award.
- 3. The Knight Commander of the Temple (fee \$200.00) may be awarded to any **Templar** for service to the Order, the Fraternity, or the community. Nominations may be submitted by any current holder of the Knight Commander of the Temple. Nominations must be submitted in writing to the Deputy of the College of Honors at least 90 days before the desired award date, and should be in sufficient detail to describe the exceptional service made. While there is no specific quota or limit, the guidelines are that not more than 1-2% of the membership of the Grand Commandery should be holders of the award.
- 4. The *Meritorious Service Award* (fee \$110.00) may be awarded by a Commandery to one Templar each Templar year. There is no specified form for submission, but a narrative is required. Nominations must be submitted in writing to the Deputy of the College of Honors

at least 90 days before the desired award date, and should be in sufficient detail to describe the exceptional service made.

The committee will submit a full report for the Annual Conclave in October.


