Thank you each for your attendance and attention at this mid-term meeting to catch all up on the recent past and prepare the path for the future.

I again wish to thank you all for the support and respect that has been offered to me and the Grand Line officers as we continue to visit the Commanderies to inform and assist and attend Masonic and public events to promote the Knights Templar of Maryland.

My report today will recount the stated goals of the KT of Maryland and give progress status of our Commanderies and programs.

Overall health- The Commanderies of Maryland remain in a state of flux with some thriving and others faltering. We cannot fail to notice that during the covid era, life changed. We continue to feel the effects- Masonry had to be put on hold for a while for many folks, The

Commanderies of America were put on standby and were among the last to re-emerge. We continue to see low attendance and several of our commanderies are rebuilding.

I am very pleased with the cross visiting and assistance by our Fraters that has been taking place and encourage all to do likewise. It is what we need to do to rebuild. Changes will take place, with some Commanderies doing better more rapidly, and others flagging until we can successfully reinvigorate them. Along those lines the Degrees and Orders of the York Rite have been conferred lately in several places with teams made up of several participating YR groups. As example the Order of the Temple will be conferred 3 times in the month of June using Sir Knights from several Commanderies to make this possible.

In this era of diminishing membership, and until we right the ship in all Masonic organizations, fewer people means that those dedicated members wind up taking on more and more jobs, in order to keep those organizations viable. I salute those of you who are taking on this added responsibility and will do all I can to encourage growth and assistance to all these fine Masonic organizations.

Progress and diminished attendance mean change and here is an example: Two fine historic Commanderies facing a diminished area of influence and personnel have come together. Recent votes to unite have been taken, and very soon, Beauseant No. 8 and Carroll No. 11 will be one. I believe it will be established as Carroll Beauseant Commandery No. 8. I wish to congratulate Eminent Commanders Bob Candler and Mike Rabb (stand) and their knights on an excellent effort to cross visit, meet and discuss the relationship and develop a plan for two Commanderies to unite and become one viable unit of dedicated knights. The wonderful attention of Right Eminent Past Grand Commander Richard Naegele has made this smooth and seamless.

KTEF- Last year we made the historic leap as one of the few Commanderies in the world to become 100 percent engaged as Life Sponsors of the Knights Templar Eye foundation. Grand Generalissimo and Chairman of the KTEF, SK Gary Kennedy, and SK Eminent Commander Bob Candler made this possible with the help of Jacques DeMolay Commandery No. 4 and Beauseant Commandery No. 8. Many thanks to them for this accomplishment. This means however, that we need to sustain that status in perpetuity. Each commandery, must keep its eye on the prize and assure that each NEW knight is enrolled in the Life Sponsor program. We continue to exhort the membership of the value of this financial

participation and suggest methods of continuing the dedicated effort of support to this valuable asset to the sight of others around the world.

KT Education Foundation- While the past year has had ups and downs in the finances of the US Banking system, our accounts as you will soon see are continuing to prosper. This is important as our Scholarship program continues to reward deserving young people and Sir Knights as they further their education. We have been making a concerted effort to raise the awareness of the Knights Templar Education Foundation among Masonic members. Last year we had a great number of applications, and we were able to award handsome scholarships to a number of deserving students. This year, we have not had the same effort and it shows, the applications are down significantly. There is time, however, to recoup. In two weeks, on June 30 we have a deadline for applications to be submitted to our Chairman REPGC Art Hebbeler. Please, please- tomorrow, get the word out, to all of your members to have their loved ones that are in ready for college or seeking to obtain further education, or certification for a current job. As long as the applications are in our hands by the 30th of June, the remaining documentation asked for in the application can be sent along at a later date.

Religious observances- I am beyond happy with the increased awareness of, and participation in, public ceremonies of our Christian religion continues to prosper and be made a part of Knights Templar service. My gratitude to our Eminent Grand Prelate Charles Beckhardt, grows with every month he has served. He continues to educate and inform the Commanderies of the importance of our public and private need of Salvation and how to go about it in Christian and Templar fellowship. Thank you Sir Knight Charles. One final opportunity for your participation is on hand on May 22 when Antioch Commandery in Cumberland will hold an Ascension day service in Cumberland.

Holy Land Pilgrimage- This year the members of Chesapeake Commandery No. 10, at the urging of REPGC Clifton Friel and the workmanlike efforts of SK Vernon Huebschman encouraged and sent a wonderful minister from the Denton area on the journey of a lifetime through the Holy Land Pilgrimage Program. Congrats to Reverend Robyn Brown and the Sir Knights of Chesapeake No. 10.

Youth programs- My wife Kandi and I have attended Rainbow Girls and DeMolay events this year and we have been very impressed with the work done by these young people and the dedicated Masons and their wives that support and encourage them. Knights Templar have had a long history of financial support and a program to assist them with membership through a yearly outing for relaxation and camaraderie.

The past several years Grand Captain General SK Scott Lapp and his wife Marcie have headed this program and he has delivered a report which you will hear or read with this year's upcoming program. Thank you, SK Scott, and please pass along our best wishes to Companion of the Temple Marcie.

KT Handbook/ Knight training- I had hoped to have this effort well on its way, however we got a slow start, and I can now report some limited progress as the Handbook Committee has only had a couple of meetings to get the ball rolling. We will continue and I hope to have a modern and up to date booklet prepared to go to printing in fall or winter.

New Knight Training is again going to take place under the leadership of REPGC Charles Warns and his team of Sir Knights. The first of these will take place next month here in the Gothic Room on Saturday June 17th. Notification and application for attendance has been sent out. I encourage all new Sir knights and those of you that have never seen the program, or wish for a refresher, to attend. There is no fee and lunch will be served. Thank you, SK Past Grand Commander Chuck, for putting this together.

Public Ceremonies/Masonic ceremonies- raising the visibility of the Knights Templar is being accomplished regularly by the participation of Sir knights in Public ceremonies such as open Lodge installation flag presentations, Parades, public religious ceremonies such as the Christmas Observances, Easter Sunrise service and ceremonial participation in the attendance at Other Masonic events. I want to thank those officers of Commanderies that participated in Lodge Flag

presentations, The Baltimore Mayor's Parade, unprecedented Christmas observances, forming the Cross of Honor at this year's Easter sunrise service, attendance at the ceremony for the status of Grand Recorder Emeritus for SK Kris Brown and participation in the celebration of the 100th anniversary of the Completion and dedication of the George Washington Masonic National memorial in Alexandria Virginia just to name a few. The latter event we have had on our radar for 5 years and the Grand Commandery, first under the leadership of REPGC Warns, and then myself have contributed financially to the recent renovations and the ceremony of re-dedication which took place at the memorial in March. The count of attending Masons from around the world varies but an estimated 3500 to 5000 Masons marched in the Parade before the ceremony or attended the outdoor ceremony. I want to thank all of those Sir Knights that were able to attend. I must comment that one of our Sir Knights-Richard Thurfield in cooperation with the Scottish Rite House of the Temple made the public access of the GWMNM event and the Easter Sunrise event available by live streaming on the internet. Thank you Sir Knight Richard. (Show plaque)

The next opportunity looms and will be at the Memorial day Parade later this month where the Knights Templar of Maryland are invited to join me and the Grand Line of Knights Templar as we join the Knights of Carroll Commandery and unfurl, for the first time in public, the brand new Grand Templar Banner designed and purchased by Eminent Grand Generalissimo Gary Kennedy (stand and show off banner). Thank you SK Gary- Come and join us in this March on May 29th in Westminster. Notification of upcoming celebrations of the 150th anniversaries of both Palestine Commandery No. 7 and Antioch Commandery No. 6 will be here in the next few months.

Stay tuned for further information which will be posted under the events section of the website.

In my role as your Grand Commander, I have had ceremonial opportunities before the Grand Lodge of Maryland, Youth Groups, Eastern Star, Knight Masons, AMD, Knights preceptors, Holy Royal Arch Knight Templar Priests, Past Masters Association, York Rite College, Chapter and Council, Grand Encampment, The Grand Conclaves of Delaware, District of Columbia, The Bicentennial of Grand Commandery of Virginia 2 weeks ago, and later this week at the Grand Commandery of West Virginia.

A new opportunity has surfaced at Boumi Shrine with the Shrine developing a program to educate their members on other Masonic organizations such as the York Rite and Scottish Rite in what is called the Arch Ceremony. Eminent Commander Bob Candler was instrumental in having members of the Knights Templar and other York Rite bodies assist with this unique program. Sir Knight Randy Disney and I were participants in the inaugural ceremony, and It continues to be an ongoing program that we support and will continue to participate in.

Passing of another great Templar- Just this past Saturday we were saddened but honored to be invited to Door To Virtue lodge to celebrate the life of the aforementioned REPGC Randolph Disney with a Knight Templar Memorial service, followed by ceremonies by Chapter and Council leadership and overseen by his brother Worshipful Master Jeff Disney who presided over a Masonic service with Chaplain, Sir Knight Gordon Davids. Randy was a unique individual. He never passed up an opportunity to guide and assist others. He was an incredible ritualist that practiced his craft whenever he got the opportunity. As a Past Most Illustrious Grand Master of the Council, a dais officer in Grand Chapter, Past Grand Commander, Past Governor of the York Rite College and Grand Lecturer of both Chapter and Council, he had many opportunities. Let us pay homage with a moment of silence to honor our hero, now passed. Sir knights please rise, Uncover. And add your silent prayers.

REPGC Randy was our Grand Inspector General and had just begun to travel with me and present his plan to reinvigorate the Ritual of the Knights Templar in the State of Maryland. As of this date we are not yet ready to outline how that vision will play out with a new GIG, but I would urge all Commanderies to shine up their Knights for review and I will begin Grand Visitations with the Grand Line in Late June to continue into the fall.

The report takes about fifteen minutes if you have the information prepared before you go online from the York Rite Website link. Once your report is filed you must return in about a week to verify that the report is approved or rejected. Most commonly, the reports are accepted.
- 2. Annual Reports and Assessments: This year the Grand Secretary sent out a billing statement to each of the Commandery Recorders. As of this writing, all the Commanderies have paid their annual assessments. The assessments are based upon the Annual Report as calculated by the Grand Encampment's Membership Management System.
- 3. Ordering Rituals: Commanderies needing Ritual Books can order them through the Grand Recorder. There will be an inventory of spiral bound books typically, though there is a small supply of the hard bound version, which can be mailed out in quantities as ordered until the existing supply is exhausted. After that, the hard bound books will be ordered in lots of ten and will be dropped shipped from the Grand Encampment Officers in Texas directly to the Recorder.
- 4. Web Site: SK Dan Brewer is working on posting the Proceedings from 2022 and the Constitution of Grand Constitution. Please take the time to explore the site and its growing list of assets.
- 5. Grand Encampment MMS: Congratulations to the Commandery Recorders in maintaining their memberships in time for the December 31, 2022, deadline for the Annual Reports. Also, for posting in the election and installation of their respective line of officers. Please post information concerning the conferral of the Orders within 48 hours of each such occasion. This makes life easier for the Recorder in the long run. The MMS is an impressive and accessible fountain of information which can lead to wisdom. Please don't hesitate to explore the MMS...you can't hurt it. Some data inputs cannot be reversed locally but even incorrect or trail inputs can be undone by the Grand Encampment. SK John Elkinton in Texas has been an invaluable assistance and guide in learning the ropes of this system.
- 6. School for Secretaries, Recorders, and Treasurers: Many thanks to SK Bill Eppig and SK John Rafine for conducting the 2023 School. I was unable to attend due to a family illness. With the significant turnover of secretaries and recorders, it was felt that there was a need for another round of this school for basic administrative skills. If any Recorder has specific questions or suggestions, I will try to respond with what I have learned in my tenure as a local Recorder, and what I have learned from SK Kris Brown and the staff at the Grand Encampment Office.
- 7. 2024 Dues Billing: Please use the coming summer months to prepare for your 2024 Dues Billing. Try to mail out in September. It is not necessary to have the dues cards in hand to begin receiving dues. The cards come out of Texas directly. The local Recorders should be applying a seal to each card. I recommend using a miniature wet seal for this purpose rather than a full size embossing seal.
- 8. If your Commandery or York Rite center would like to explore using credit cards for the payment of dues bills, please contact me later. You will need to vote to utilize this modern technology, so you may need want to delay your dues billing to announce the new process. You can also use credit cards for the reception of Petition payments and for special events.
- 9. Those Commanderies which have Knighted new members since this time last year should make every effort to have the new members make a \$30 donation to the Knight Templar Eye Foundation, or the Commandery should take such steps as necessary to maintain its 100% status of Lifetime Memberships.

Grand Commander, thank you for the opportunity to serve the Grand Commandery, you and your Line. I appreciate your patience with my inexperience and your support for my efforts.

9 Report of the Grand Treasurer

SK Randall L. Watson

This Report covers the period from November 1, 2022, to May 10, 2023, regarding the 2023 income and expenses. Income thus far totals \$10,965.00; expenses total \$9,623.63.

Asset & Liabilities Cash Statement:

- The balance in the operating account with Morgan Stanley as of September 30, 2022 was \$304,707.45; as of April 30, 2023 it is \$311,775.38; an increase of about \$7k (2.3%).
- The balance in the Endowment Fund with Morgan Stanley as of September 30, 2022 was \$724,036.63; as of April 30, 2023 it is \$832,964.60; an increase of about \$109k (15.0%).
- The balance in the Educational Foundation with Morgan Stanley as of September 30, 2022 was \$605,753.53; as of April 30, 2022 it is \$674,740.77; an increase of about \$69k (11.4%).

The above values reflect the wide market swings, where the first Quarter of this year has recovered the losses incurred in the beginning of 2022. The attached chart shows the changes for the full year from April 2022 to April 2023. The Endowment Fund had no spending and increased by 3.0%. The Educational Foundation is almost the same balance, so the increase in value almost exactly offset the \$20k in spending. The Operating Account decrease of \$34k reflects the drawdown of about \$33k shown in Income Category M in the operating expenses chart. (Most of the 2023 Assessment checks were deposited after April 30th.)

The Budget and Finance Committees met virtually on April 11, 2023.

2022/2023 Budget:

Each year we are allowed to transfer 90% of the earnings of the Endowment Account into the Operating Account. It's calculated from April 1st through March 31st. For the 2021-2022 year, this comes to \$24,877.02 (90% of \$27,641.13). This transfer has not yet been completed and was not included as income in the preparation of the 2022/2023 Budget, since the Operating Account has sufficient reserves to fund the Budget while leaving these funds in the Endowment Account. I will introduce a motion to authorize leaving these funds in the Endowment Account, just as we did last year, until such future time as they are needed. The cumulative balance of transfers deferred from the years ending March 2017 through March 2023 is \$122,399.29.

This committee is pleased to provide the requested information as we continue our efforts to increase our membership of Knights Templar in Maryland. The membership committee has continued to be active since our Annual Conclave. As the Grand Commandery Officers have traveled with the REGC around the state we have had the opportunity to hear from the membership chairman from most of our commanderies as to their membership status.

As we strive to increase our membership it is important to have an accurate picture of where we currently stand. Our Eminent Grand Recorder SK Vernon Huebschman has played a key role assisting with this committee and the MMS.

As of October 22, 2022, we had 921 Sir Knights on the membership roster.

As of May 8. 2023, we have 913.

We had (13) Sir Knights who have passed away.

We had (1) who was Knighted, (9) who affiliated, (3) who demitted, (1) who was suspended, (4) who were reinstated, a net loss of (8).

We have one Commandery that is having difficulty with attendance. This Commandery has been assisted by Sir Knights from another Commandery and during the last few months they have continued a merger of the two, and if all goes well, will benefit both. We are encouraged by this development.

Public awareness and a public presence in our local communities is imperative to our membership. As Knights Templar we have a responsibility to assist those in need, now more than ever.

Some of the activities that constituent commanderies engaged in community involvement and awareness included presenting charitable contributions to various organizations throughout their area to assist with healthcare, homelessness, food assistance, and youth groups.

Quartermaster 2023 Semi-Annual report

REGC.

The Quartermaster committee is in the process of restocking as well as enlarging the Uniform accessory inventory as previously discussed. Below please find a list of the things that are currently in progress for the Quartermaster Department:

- 1. Uniform Name Tags: At your direction the Quartermaster has been providing regulation ¾" x 3" gold tone name badges to many sir knights. In the coming weeks we will be sending out additional notification to all the Commanderies that the Grand Commandery will be providing regulation name badges to all sir knights who need them.
- 2. The Grand Commandery, thru the Quartermaster Department, currently has two programs now in place to help offset the cost to our Sir Knights to acquire a proper regulation Knights Templar Uniform. They are the Sword Program and the Uniform Accessory Assistance Program as detailed below.

Grand Commandery of Maryland Uniform Assistance Programs - 2023

In order to help minimize the cost of outfitting a Sir Knight in a proper uniform according to the Uniform Regulations, the Grand Commandery of Maryland is offering the following Assistance Programs:

Option #1: Sword Program

If a Sir Knight acquires a complete uniform and hat (either a chapeau or a dress cap) that meets the current Uniform Regulations without Grand Commandery subsidies, then the Grand Commandery of Maryland will give that Sir Knight a sword at no charge.

Option #2: Uniform Accessory Assistance Program

If a Sir Knight acquires a plain proper regulation uniform coat and hat (either a chapeau or a dress cap) then the Grand Commandery of Maryland will sell the uniform accessories that the Sir Knight needs to trim out his uniform and hat at half price. These accessories currently include sleeve braid, sleeve crosses, collar pins (MD and #), Cap crosses, Chapeau rosettes, Swords, Sword slings, Gloves and Past Commander shoulder boards as currently inventoried by the Grand Commandery Quartermaster.

While the Grand Commandery cannot do anything to offset the cost of the uniform coat or hat to the Sir Knight, it can however, with this program, help offset the cost of the accessories. Please note that it is still the Sir Knight's responsibility and at his expense, to have the uniform accessories properly installed on his uniform.

This program is also available to existing Sir Knights who need to upgrade their current uniform. For example, when a Sir Knight becomes a Commander or Past Commander he needs to replace his Silver Sir Knight accessories with Gold Commander/Past Commander accessories.

To take advantage of the above programs the Sir Knight must go thru his Commandery Recorder, or the Uniform contact person appointed by his Commander. Either of those two will then place the order with the Grand Commandery Quartermaster. The items will then be shipped out or delivered accordingly and the Quartermaster will invoice the Sir Knight's Commandery for the cost of these uniform accessories along with any shipping costs. It will then be the

responsibility of that Commandery to collect those funds from its Sir Knight. Only the Commandery Recorder or Uniform contact person may place orders with the Quartermaster.

While it is not required, it is highly recommended that each Commandery, according to its own financial means, further subsidize these items by covering some of the cost of these items. It is up to each Commandery whether they want to collect the entire cost, part of the cost or none of the cost from its Sir Knight. The whole purpose of the above programs is to help reduce the out of pocket expense to our Sir Knights for a complete and proper uniform.

A list of the items that are currently available from the Quartermaster will be posted to the Quartermaster's Page on the Grand Commandery's website.

3. Hopefully by the end of May we plan to have the Quartermaster's Page on the Grand Commandery Website up and running. Some of the information that will be posted on that page will be the Uniform Regulations in simplified layman's terms, Pictures, and descriptions of what constitutes a regulation uniform in Maryland, the Grand Commandery Uniform assistance Programs, and Items that are available for purchase from the Quartermaster by the Commanderies for their Sir Knight's uniforms.

This committee is pleased to provide the requested information as we continue our efforts to provide the best Sessions experience for our Sir Knights, Ladies, and Distinguished Guests.

Our goal is to make sure all attendees have a pleasurable stay while at the same time attending to the important business at hand.

In collaboration with our other York Rite Grand Bodies, we are pleased to welcome our Sir Knights, Companions, Youth Groups, Ladies, and our Distinguished Guests from other jurisdictions.

We are pleased to report that registration for our 2022 Sessions had increased significantly from 2021 across the board.

Our Ladies are an integral part of our organization as they always are there to support us, whether it is behind the scenes or at these events and we are so grateful to them for that. We are working to have the other York Rite Grand Bodies to join us in supporting the Ladies Program next year. Registration for the program is up almost 40% this year.
