Executive Summary of the 2025 Semi-annual Conclave:

The Reports of the Officers and Committees of the Grand Commandery of Maryland were published in a Conclave Packet distributed in the Asylum, together with the Report of the Grand Treasurer. And received and accepted for publication in the Proceedings. There were ad-hoc reports given on the floor which will be published in the proceedings. These extemporaneous reports did not require action by the Grand Commandery.

Credentials Report:

- Eight of Ten Constituent Commanderies represented with voting members.
- Twenty-seven (27) Voting Sir Knights in attendance.
- Five (5) non-voting Sir Knights in attendance.
- Six Past Grand Commanders in attendance.
- Two members of the Grand Line were absent, chairs filled by SK Richard P. Naegele, KCT (SW), and SK Ronald L. Aughenbaugh KCT. (JW). All other officers were present.

An announcement was made that SK Michael Raab has been appointed as the webmaster of a new version of the Grand Commandery's website which is now under construction. This effort is being made in coordination with the Grand Chapter and Grand Council which are encouraged to make similar improvements at this time.

SK Norman Henthorn, Eminent Commander of Maryland Commandery No. 1, is now the Quartermaster for the Grand Commandery. Items required for KT Uniforms may now be purchased from him or through him. The Grand Commandery now has the facilities needed to accept credit card payments for items ordered through the Quartermaster.

The following items were brought to the floor as motions, seconded and passed:

- The Proceedings of the 2025 Annual Grand Conclave were accepted and approved as published on the Grand Recorder's webpage (yorkritemaryland.org).
- The 2025 2026 Annual Budget was presented and approved.
- A motion was made to defer the annual transfer of funds to the Operating Account, reserving the right to make that transfer in the future, if needed.
- A set of proposals for the Amendment of Uniform Regulations were read into the Proceedings for Consideration at the Annual Grand Conclave in October 2025.
- The Grand Commandery concurred the selection of The Holiday Inn in Ocean City, Maryland as the site
 of the 2026 York Rite Grand Sessions, having been accepted previously in Grand Chapter and Grand
 Council.
- The Proposed Amendment concerning the dates for Elections and Installations of constituent Commanderies was approved unanimously. Elections must be held on Good Friday or the Conclave immediately preceding; Installations must be held on the first Conclave following Easter Sunday.
- A motion was made to pay two neglected reimbursements for the 2024 Grand Sessions in the amount of \$250.00 each, passed.
- A motion was made to support the Social Order of the Beauseant Chapter being formed at Cockeysville, as long as the effort to charter that group remains viable.in the amount of \$2500.00, passed.

4. EXECUTIVE REPORTS

4.a. PROCEEDINGS FROM OCTOBER 2024

Right Eminent Grand Commander,

As the Proceedings the 2024 Annual Grand Conclave have been posted to yorkritemaryland.org on the Grand Recorder's tab since November of 2024, and since there have been no additions or corrections offered, I move that the Proceedings be accepted as published, subject to spelling and grammatical changes without further actions required.

4.b. GRAND COMMANDERS'S ADDRESS

SK SCOTT G. LAPP, REGC

Being the Semi-annual, I am also conducting it semi-formal and will just recap some of the highlights of my thoughts in the meeting. This record will stand to bridge the gaps of information that we did not have time or inclination to cover but will be precursor to the more formal and lengthy report of the Annual in October 2025.

First off, thank you all for your support for the first year of my term. I have been given a lot of support, encouragement, advice, criticism, and opportunity. And I take the best lessons from each that I can and try to make ours a better Grand Commandery and product thereby. Here are some of the key points:

Membership – We are rolling out several initiatives to increase our membership, like increasing ease of communication by getting the word out on activities more and updating the website to make it easier for our Companions to know what's going on and how to get involved. We are also helping a few struggling Commanderies with staying afloat, by helping them learn and conduct ritual, moving location to try to tap into more potential candidates for membership, etc. These initiatives are still in play and after all it has only been six months. But we will have updates along the way, and at the Annual Conclave. Now for the downside. For the last several years, some of the Constituent Chapters, Councils, and Commanderies have not cleaned up their rosters, but now with the assistance of the MMS and the Grand Encampment, the corresponding

recorders are getting a handle on their rosters and the subsequent NPDs. And as they pile up and get demits and such, this is the year for several suspensions and other actions that will shrink our rosters. This will make the overall picture a bit more bleaker, but the truth is the truth of it and it is better to deal with it now than let it perpetuate further. How can each of us combat this? Simple; 1) stay healthy and get to meetings. 2) ask a companion from your Constituency to come back and join you, to get involved, and remove themselves from consideration for dismissal. 3) PAY YOUR DUES and get current, so NPD actions do not have to take you away from the York Rite that you honestly must enjoy. And 4) call me or one of my officers and find out what's new in Commandery (there is a lot of new happenings actually), or better yet, come to the next meeting and see what the Commandery has to offer since you last were there.

As far as numbers, we are sitting at 843, down from 895 last year. At that rate of attrition, Maryland's Knights Templar will be extinct in a matter of about 12-15 years. It is not the job of just our Commanders, but rather each of us, to start acting now to turn this tide. There are plenty of ways to help out if you'd like to discuss them. Call me or come visit, and I will make sure to have that discussion with each and every one of you. But know that in the last few years, we have lost some Commanderies, and a few are still teetering on the edge. If you don't want to see the state operating just a handful of Commanderies far from your home, we have to keep them all viable.

Ritual – Is now the bailiwick of our Grand Inspector General, Fred Spicer, PGC. He is doing a great job getting to all the Commanderies and inspecting them and assisting them with practicing to get better. Darryl Smith, EC #3, is in place to assist him and also was tasked with keeping an eye on the candidate pipeline so that no one is left in for multiple years as was the case before we cleaned it out two years ago. Also, one of the greatest complaints recently has been of not having access to an affirmed set of ritual to work with. Everyone seems to have their own book, no two the same, to work from. So expect a committee shortly on what we can do to fix that.

As for our progress, I would direct you to see the GIG's report included in this packet. And again, my thanks to GIG Spicer for coming back to the role and keeping Ritual in our hearts and minds.

Constitution – Jurisprudence has been reviewing the regulations that guide our institution, and that committee is in good hands and being led by SK Richard Naegele, PGM, PGC, etc. We will have some changes to be voted upon this Semi-Annual, and some more at the Annual. If you see changes therein that you think need to be made, come volunteer to help out and get on a committee to do just that. And make sure if you are concerned about any potential changes upcoming, to be at the Annual and make your voice heard by vote.

Media committee – is underway and making some changes to our website and the way it is handled and billed. The Commandery, in an effort to not be alone on it's own island, is making efforts to work with the Grand Chapter and Council to make those changes more universal and across the York Rite in general, so we can all benefit from it. More on that in my verbal address...

Observances – Our Constituents have made good effort to keep all four of our mandatory observances at the forefront of our Sir Knights' thoughts and we have seen Christmas and Easter services held this year that haven't been conducted in years. It makes my heart glad to see everyone embracing their Christian motivations and attending and organizing these observances. SK Charles Beckhardt, G.P. is working with others like SK Dean Burt across the state to make it a truly cooperative set of events. If your Commandery can't hold one of it's own, I urge you to team up with another who can help you or host you at theirs. The goal here is to make sure services are available to ALL Sir Knights, not just because of our requirements, but so that we can keep Christianity and our virtues at the top of our minds and hearts. Without them, we are just

another philanthropic community group. And I don't know about you, but that's not why I joined the ranks of our Order.

Necrology – A report will be given, and memorial services will be help at the Annual Conclave. In the meantime, if you have news of the passing of a Sir Knight, please have your recorder forward that information to us as appropriate.

I would like to take a moment to recognize that SK Robert Young will have a Memorial Service on June 7th at the Grand Lodge, consisting of services from the Knights Templar (KT#3) as well as other Masonic bodies, as requested by the family. Anyone who wishes to attend, please contact SK Norm Henthorn, Recorder, or SK Darryl Smith, EC for information on how and when to attend. As a member of Monumental Crusade #3, I had the pleasure of working with Bob with our rituals and learned a lot from him. He will be sorely missed from those ranks.

Visitations – To date, I have visited more than half of the Constituent Commanderies so far this term (Since last November) and expect to visit the rest before the year is up at the Annual. I expect to get to them all at least once next year as well, but obviously, I make those who need greater assistance a larger priority. In fact, your Grand Commandery is not a lone Commander, but a really productive team, and although I have not been to each as yet, I have taken other steps to cover them, so they are not alone. My GIG has been to most of them so far and plans to go again. For the few I have not been to yet, my officers have reached out on my behalf and will also be attending them and assisting them. And I took the liberty of setting up my line so that most of the Constituents had a Grand Line Officer either stationed at their commandery or at the next one regionally, so they have that officer in proximity to help as well. The resources are there, and if any Commandery has additional need, all they need do is raise the alarm and we will muster to the cause.

I have also made it a point to visit Grand Commandery Sessions of our neighbors, all of the Mid-Atlantic's and one of the Norst East Department. I know some believe that Maryland has all the answers, and while I agree Maryland is a Great region for Templary, we do not presume to know it all. I have made a lot of contacts in these states, and learned a lot of ideas from them, things that work and things that didn't. Some of these ideas I will be bringing back to our state to try to use them to invigorate ourselves. Time will tell, but there is certainly a wealth of knowledge and brethren to learn from within our department and to not do so is a waste of resources. I have encouraged my officers to travel with me and can give a full report to anyone who requests it, but I also would suggest to anyone who has the opportunity to attend one of those other Sessions, to do so and keep an open mind. It will broaden your view of Templary.

Awards - We are working to improve the use and knowledge of our programs and the Meritorious Service Award in particular. In my opinion, every Commandery should recommend one of their ranks each year for this medal. Not for the medal's sake, but to take a moment to acknowledge efforts of particular knights to improve their home Commanderies and inspire them to do still more. It is a minimal cost, but can be a strong motivator for the troops. And my bigger concern is if you and your E.C. cannot think of a deserving Sir Knight in your ranks; no one who has exerted sufficient force to stand out as deserving of such an award, then that says more about your Commandery's ability than any one Sir Knight.

More to come at the Annual on this topic...

A reminder will be made in my address reminding members that the Grand Master, David Kussman, has endorsed cooperation and assistance for our ladies of the Social Order of the Beauseant. He is also promoting more chivalrous behavior as behooves a knight. We in Maryland are doing the same. We ask that each of you assist the S.O.O.B. where possible and extend them, and all ladies, a greater degree of chivalric and

gentlemanly behavior. It compliments them and reflects well upon ourselves. And in so doing, promotes brotherly love as we treat each other better in the process too. We are not just men, nor masons, but Knights - govern yourselves accordingly.

In closing, I want to thank you all again for the myriad of efforts put forth by you all. It is great support not only to myself, but our entire state of Templary and we would be nothing without you.

4.c. REPORT OF THE GRAND RECORDER

Right Eminent Grand Commander,

- 1. Per your instruction, SK J. Bradley Thomas has been appointed as Assistant Grand Recorder. Your directive was to devise a plan to train SK Thomasin activities and duties of the Office of the Grand Recorder. To that end, I have assigned as his first duty, the assembly of the Conclave Packet we each hold in our hands today. This packet will become the backbone of the Proceedings which remains my duty to compile and publish. I am deeply grateful for his service and look forward to continuing this process.
- 2. Having an Assistant Grand Recorder, I should say that it is my intention to be available for consideration to serve as Grand Recorder until the Grand Conclave of 2027. This being true as long as my health and acuity remain intact. Serving this Grand Commandery is a blessing for me, and I deeply enjoy working with the Officers of the Grand Commandery, and the Recorders and Commanders of our Constituent Commanderies.
- 3. The Recorders and Commanders of our Constituent Commanderies are reminded that the IRS 990n forms can be filed after the first day of January of each year, unless your Commandery has been issued its own EIN, probably beginning with a "52" prefix. You will need to verify your filing window.
- 4. Regarding the EIN, please note that the name for your organization shown on your IRS 990n form is the true legal name for your organization. If you are operating a checking account with any other name...even the commonly used name of the commandery which traditionally use, your financial institution may eventually need to call you in. Setting up a Doing Business As identity is a workable solution. You will need to make sure your Commandery is registered with the State of Maryland and establish their version of an EIN...you have your own federal EIN....and you should have 501 C 10 classification, but you may need a copy of your Determination Letter from the IRS.
- 5. Recorders, please remain focused on updating the MMS with each event that alters a Sir Knight's membership status: Conferral of Orders, change of contact information, death, demits, suspensions. Remember that the MMS is a shared information system that benefits from your activity in both the Chapter and Council, although your Templar data is private to your body.

Grand Commander, thank for the many conversations and emails. I have enjoyed the frankness of our communications. Many leaders have called for improved communication, but you have made this concept the foundation of all your efforts.

4.f. GRAND TREASURER'S REPORT

SK RANDALL L. WATSON, KCT

This Report covers the period from November 1, 2024 to May 14, 2025 regarding the 2025 income and expenses. Income thus far totals \$13,328.00; expenses total \$7,925.71.

Asset & Liabilities Cash Statement:

The attached chart shows the changes for the full year from April 2024 to April 2025. In reporting for the full year, the investment increases from April to September in 2024 mask the decreases from September 2024 to April 2025. The Endowment Fund had no spending and increased by 10.09%. The Educational Foundation increased by 7.42%, but one \$5k scholarship check from the previous year was reissued and cashed. The Operating Account increased by 7.46%.

- The balance in the operating account with Morgan Stanley as of September 30, 2024 was \$318,246.59; as of April 30, 2025 it is \$302,213.35; a decrease of about \$16,000 (5.0%).
- The balance in the Endowment Fund with Morgan Stanley as of September 30, 2024 was \$1,086,032.11; as of April 30, 2025 it is \$1,055,467.54; a decrease of about \$30.5k (-2.8%).
- The balance in the Educational Foundation with Morgan Stanley as of September 30, 2024 was \$848,487.51; as of April 30, 2025 it is \$806,518.69; a decrease of about \$42k (5.0%).

The Budget and Finance Committee Chairman reviewed the Grand Treasurer's records on April 23, 2025. The Committee met virtually on April 25, 2025.

2024/2025 Budget:

Each year we are allowed to transfer 90% of the earnings of the Endowment Account into the Operating Account. It's calculated from April 1st through March 31st. For the 2024-2025 year, this comes to \$28,770.79 (90% of \$31,967.54). This transfer has not yet been completed, and was not included as income last spring in the preparation of the 2024/2025 Budget, since the Operating Account has sufficient reserves to fund the Budget while leaving these funds in the Endowment Account. I will introduce a motion to authorize leaving these funds in the Endowment Account, just as we did last year, until such future time as they are needed. The cumulative balance of transfers deferred from the years ending March 2017 through March 2025 is \$191,454.67.

Your youth trip committee thanks you for the opportunity to serve this august body by working with our Masonic Youth.

The young men and women will be part of our future either through joining or encouraging others to join. Our continued support will only afford them greater success in their futures as well as the communities.
