REPORT OF THE GRAND SECRETARY

Most Excellent Grand High Priest,

IRS:

Thanks to the Chapters that have complied with the request for a copy of the Form 990 Confirmation to be submitted with the Annual Report.

The Grand Chapter is requested annually to supply the current list of subordinate bodies with contact information and current EIN's. With the number of Chapters that have been issued new EIN's I have asked our Chapter Secretaries to provide a confirmation of the most current EIN and contact person.

Maryland has two Chapters that are working on the restoration of their Tax Exempt Status. This is not a pleasant procedure, and it is also expensive. All MEHP's are requested to verify that their Secretary has completed the brief IRS 990 Form each year.

Waivers of Territorial Jurisdiction among our Sister Grand Jurisdictions:

The Grand Chapter of Maryland has issued 2 Waivers of Territorial Jurisdiction to the Grand Chapter of Washington, DC. Specifically related to the Multi-Jurisdictional Festival. As there have appeared to be some lapses in the protocol regarding Waivers of Territorial Jurisdiction among our neighboring Grand Chapter, Maryland will be issuing letters to the neighboring jurisdictions to clarify the procedure regarding acting upon Brothers who are residents of Maryland. And as the duties of Freemasonry are reciprocal, Maryland Chapters are reminded they may not act upon Brothers resident in other states without contacting the Grand Secretary of the Grand Chapter of Maryland, who will, in turn, may the necessary contact with his counterpart in the respective jurisdiction. This can be done in a day or two... but please don't wait to the last minute.

Report of the Grand Secretary (Continued)

Annual Reports:

This has not been our best year in getting these reports in a timely fashion, and with useful information. This may be because we have had an unusual turn-over in Secretaries. Two of our Secretaries, Comp. Bob Madel of Mt. Vernon RAC No. 25 and Comp. Gerald Dawson, Sr. of Chesapeake RAC No. 17 passed away over the summer. These were beloved friends, Brothers, Companions, Sir Knights and wonder men who shouldered the work of keeping their Chapter moving forward.

The Annual Reports are a snapshot of the Chapter on August 31st of each year, but the work of preparing the report can begin with the last meeting in the Spring. The Forms are available on the Grand Secretary's Page on the Website. By June most Chapters know who has been Exalted, who has died, demitted or suspended. I strongly urge all Secretaries to begin the Annual Report over the Summer months, and make any final modification immediately after September 1st.

The Annual Reports of constituent Chapters will close on August 31, 2015, and is due to the Grand Secretary by October 1, 2015 with all data supplied and all payments made to the Grand Chapter for Exaltations at \$10.00 per new member, and the Annual Per Capita Fee totaling \$9.50 per Companion on the books as of August 31st. (\$5.00 Grand Chapter Assessment, \$2.50 RARA per member assessment, and \$1.00 General Grand Chapter Assessment for 2015; \$2.00 for 2016 & 2017; and \$3.00 for 2018 and thereafter) Necessarily, Chapter should make adjustments in their dues bills to fund the coming increases

In the pass-through assessments. The dues bill for 2016 should reflect the first \$1 increase, with the second \$1 increase beginning with the 2018 dues bills. This is based on the recent summary provided by our General Grand Secretary, M.E. Comp. Larry Gray.

Royal Arch Mason Magazine:

The never- ending uphill struggle to keep the Royal Arch Mason Magazine list up to date continues with the help of our Secretaries. I will be happy to include anyone after they have received their Mark Master Degree if you will supply me the necessary contact information by email.

Membership:

The Summary Report of Membership rolls up the details of the changes in membership status from each of the reporting Chapters. At the Semi-Annual Convocation in May 2014, the Grand Chapter determined that Plural Member would not be subject to multiple Grand Chapter Assessments. This Action required culling out those members who have joined a second or third Chapter in Maryland. This has been complicated and confusing process for some. When you study the Summary Report, please focus on the Additions by Exaltations and Reinstatements, and the Deductions by Death, Demit,

and Suspension...all the rest is corrections and cleansing of the report of Plural Members so we do not double count our Companions in our reporting the General Grand Chapter.

Companions who become elected officers in their Plural Chapters have their Mother Chapter reset to the Chapter where they hold office...or the highest office. Because the Grand Chapter has a "One Man – One Vote" rule for voting, it is necessary to determine where the Companions highest duty resides. This rule currently affects M.E. Companions Bandell and Huebschman, Comp. McDonald, and Comp. Chris Jensen.

Thank you to all the Secretaries for their generous support of their Chapters, and all the officers who give so freely of their time, energy, and dedication to make our Chapter prosper.

Report of the Grand Treasurer

MEGHP,

The report of the Grand Treasurer is that the Grand Chapter is in good financial condition. The Treasurer's interim report for 2014, as of Oct. 22, 2014 is available on request.

A couple of notes, although the budgeted income from the Per Capita collected fell short of the budget the Transfer income will exceed the budget by \$471, as additional funds are received. Meanwhile, the expenses authorized at the Semi-Annual have caused some categories to exceed the budgeted amounts, it is hoped that our share of expenses for the Annual Convocation will be reduced as well as other accounts, saving funds to cover the authorized expenditure.

The Trustees report show the status of the investment account as of September 30, 2014. The value of the account and its investments as of that date was \$294, 676.43 for an overall increase during the last year of 8%

Participation

I have seen an increase in Companions, especially newer ones, at many meetings and events of the Chapters. I have been told by their High Priest their average attendance has quadrupled from previous years. A lot more work needs to be done in this area to help reach the goal of 50% growth.

To assist with encouragement we presented White Tau awards to many Companions. This is given to those who participate in ritual, attend meetings and visitation to other chapters and have been members for two years or less. Recipients of this honor please stand. I thank you for the initiative and dedication you have taken in your Chapters. You are why we are here.

Sessions

We hope that by moving the sessions around the state will allow for greater participation by the membership. Last year we were in Columbia, this year at Grand Lodge and next year will be in Ocean City.

Ritual

This has been a concern for many years to bring the ritual work back to each of the individual chapters. To do this I implemented a requirement that each Chapter exemplify or confer the Mark Master Degree. Most of them have done so and I thank them for the hard work and dedication that put in to make this happen.

I am also very pleased to see six new High Priests installed earlier this year. This is the most in a few years and shows that things are improving. Those Companions have shown dedication to the work to make this dream a reality.

Membership

While the numbers are still coming in, I am aware that more degree work was held throughout the state than in recent years. This shows the continued growth and activeness of the Chapters and is a great sign for the future of the craft.

Education

This is the one area where we are lacking. The Grand Lodge has done an outstanding job training new Masters but we in the York Rite have fallen down on the job. Many jurisdictions have taken the lead, especially New York Grand Chapter. They have developed many programs to build leaders and educate the Companions. This program has been made available for others to use. I am hoping we in Maryland will take advantage of these resources and nurture our own.

Festival for the Child

I wish to thank those Chapters, Councils and Commanderies that helped support this worthy event. It was designed to bring together the major bodies in Masonry to raise funds for their Charities which support children. They helped assemble over a dozen raffle baskets that raised over \$2,000 for the York Rite Charities of RARA, CMMRF and KTEF. The monies have been sent to all three Charities. This is probably the greatest accomplishment of the term. Having reached mutual recognition with the York Rite bodies Prince Hall was a highlight for me personally. Working with Brothers and Companions for months was a true pleasure. A special thank you for making this a reality needs to go to MWGMS Gerald Piepiora and Melvin Thorpe for their vision and guidance. Also MEGHP Johnson, MIGM Charles, and REGC Williams for this assistance and support. The chair for Prince Hall was Companion Leon Stanley, REPGC. His dedication to the craft is only surpassed by his brotherly love for his fellow man.

Recommendations

1. That all incoming Grand High Priests present a written plan prior to installation of their program and goals for the year. This should be presented to an assemblage of Past Grand High Priests prior to installation for guidance they may offer.
2. That each local Chapter formulate a strategic or long range plan to focus the chapter for the future.
3. The Grand Chapter adopted the leadership program developed by the Grand Chapter of New York and have a leadership training session next summer.
4. The Long Range planning committee meet at least semi-annually to review progress and recommend changes as needed. Also to have the Grand Council and Grand Commandery to share in this plan and adopted it at their respective sessions.
5. Recently it was brought to my attention that we no longer have festivals in the state to allow those with time constraints the opportunity to join the York Rite. While this is a plus for the local body's ability to confer the degrees, it does disenfranchise those brethren who would like to take the next steps but are unable to do so because of time commitments. This should be looked into for future planning by local bodies or the Grand Bodies.

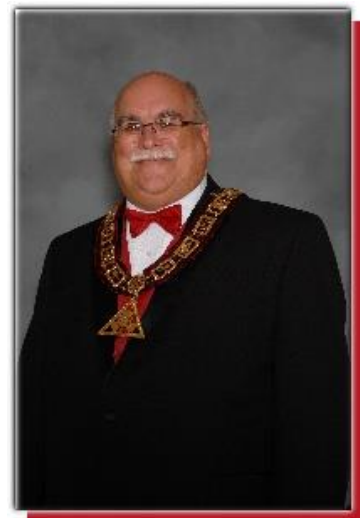

The Triennial Convocation was opened by the Officers of the Grand Chapter of New York and received the officers of the General Grand Chapter. Then they relinquished their stations to the General Grand Chapter Officers and the meeting was presided over by Edmund D. "Ted" Harrison, Most Excellent General Grand High Priest.

Distinguished guests were received from various Masonic bodies of the US and from Australia and Scotland.

Preliminary reports of the General Grand Chapter Officers and Committee Chairmen were adopted as printed in the Advanced Proceedings.

The budget of \$ 545,900.00 for 2014 – 2017 Triennium was adopted.

The following resolution was submitted and was approved by an overwhelming majority.

RESOLUTION ____ 2014-B _____

TO: The General Grand Chapter Royal Arch Masons International

Whereas the costs of all operations continue to rise, including taxes, printing, removal of monies from the Sustaining Fund Income and corpus and a multiplicity of other reasons beyond our control, it is necessary to seek a per capita increase stretched over two separate trienniums.

Therefore, be it resolved that Paragraph 2 and 3 of the Standing Regulations of the Constitution and Standing Regulations of The General Grand Chapter of Royal Arch Masons International be amended to read:

2. Subordinate Chapters of the General Grand Chapter (those chapters who are not part of a Grand Chapter) shall pay into the Treasury \$5.00 annually for each Royal Arch Mason on its rolls at the date of their preceding Annual Report. Exaltation fees will be discontinued.

3. Grand Chapters whose jurisdiction falls on the North American Continent shall pay annually, and within ninety (90) days after their Annual Convocation, into the treasury of the General Grand Chapter, the sum of two dollars (\$2.00) for each Royal Arch Mason borne upon the rolls of their subordinate Chapters at the date of their preceding annual reports. All other Grand Chapters whose jurisdiction shall fall outside of North America shall pay annually and within ninety (90) days after their Grand Convocation, into the treasury of the General Grand Chapter the sum of eight dollars US (\$8.00) for each Royal Arch Mason borne upon the rolls of their subordinate chapters at the date of their preceding annual report. (\$1.00 for North American Grand Chapters and \$4.00 increase for other Grand Chapters will take effect on January 1, 2016. Additionally, \$1.00 for North American Grand Chapters and \$2.00 for other Grand Chapters will take effect on January 1, 2018.)

REPORT ON WORK

Most Excellent Grand High Priest,

Royal Arch Memorial Service:

The Committee on Work submitted a Royal Arch Memorial Service to the Semi-Annual Grand Convocation for its consideration, and upon motion duly made and seconded it passed unanimously. The text of this service will be incorporated into the coming revision of the Grand Chapter of Maryland Ritual Book.

Division of the Lecture of the Royal Arch Degree:

Grand Chapter of Royal Arch Masons 2014 Annual Grand Convocation

Chapters may at the discretion of the MEHP, divide the work in the Royal Arch Degree, beginning with the explanation of the Signs and continuing to the end. The work may be divided among the MEHP, EK, and ES as they are seated in the East. For the purposes of Exemplifying the Degree, it is the responsibility of a rising officer to deliver all the work shown in the Ritual Books belonging to the High Priest.

Revision and Corrections to the Maryland Ritual Book

The present red wire-bound Ritual Book has served this Grand Chapter for almost fifteen years. During this time there have been additions and revisions to the content. Specifically, the Grand Chapter was approved full form openings & closings for the three subordinate Degrees of the Chapter. Also, the text of Installation of Officers has been amended, but is not commonly available in the Ritual Books. We have also approved a Chapter Memorial Service which needs to be permanently recorded.

There are also some items which may be useful to consider. The Apron Lecture from the General Grand Chapter's Ritual would be an interesting addition to ponder. There were some revisions done about a decade ago to speed up the Royal Arch Degree...some things shortened, some used a part of prologue, some made optional at the MEHP's discretion. To the end of bringing these items, the Committee on Work will undertake the preparation of a New Revised Maryland Ritual. The first task will be transcribe the existing text to a universally accessible electronic format, such as Microsoft WORD. Once this is done, we can address the possible changes to be considered. Once the final configuration is reached the document will be in a format that can be given to a publisher to edit into a useful book.

REPORT OF THE GRAND LECTURER

Most Excellent Grand High Priest,

This has been another encouraging year for the state of the Ritual Work.

- Fourteen of eighteen Chapters had new members this year.
- Four Chapters installed new High Priests
- Several Chapters have accepted the Grand Lecturer's request to work one-on-one with their Lines to improve the quality of degree work.
- The requirements for a new Most Excellent High Priest are
 - Must be a current or past Excellent King or Excellent Scribe
 - Must exemplify the presiding officer of one of the following combinations:
 - Mark Master and Most Excellent Master Degrees, or...
 - Past Master and Royal Arch Degree, or....

- Mark Master, Past Master, and either the Captain of the Host or Principal Sojourner from the Royal Arch.
-
-
- The Chapter Secretary must request a dispensation from the MEGHP for the candidate not having exemplified all four degrees, as stated in the Constitution, which must be done PRIOR to elections.
- ELECTIONS MUST BE HELD AT THE MARCH CONVOCATION.
- Properly elected Companions must present themselves to the Council of Anointed High Priests to receive the instructions of that Degree. The fee shall be paid by the Chapter. A member of the Chapter should be present with the candidate.
- The MEHP-Elect and his Line shall be installed per the requirements of the Grand Chapter Constitution, and the Chapter's Bylaws. Note this exception for the Installation of a Past High Priest: The Chapter may hold its Installation prior to the Semi-Annual Grand Convocation if convenient for the Chapter's schedule, only if the MEHP-Elect is a Past High Priest or the current High Priest.
- It is the province of the Grand High Priest to install the officers of all Chapters. If a Chapter has a particular desire to have a certain Past Grand High Priest, current elected Grand Chapter Officer, or a Past High Priest perform the Installation, if may do so with the consent of the MEGHP, using the appropriate and approved Installation Ceremony.
- The Chapter Secretary should report the Installation of Officers to the Grand Secretary so that correct information can be posted to the Grand Chapter Officers and to the Grand Chapter Website.
- All Companions selected for the Committee on Work bear the title and authority of the rank of Deputy Grand Lecturer, to be available for instruction, guidance, and certification.

Concerning Degree Work:

- Chapters are reminded that if opening on a lower Degree, the full form Opening must be used, including the Prayer & Pledge of Allegiance to the Flag, and closed accordingly.
- Candidates elected to receive the four Degrees of the Chapter must do within the Chapter which has elected them to membership, excepting only when at the discretion of the MEHP, a written request to confer Work by Courtesy is made to another Chapter. The requesting Chapter is expected to supply an escorting Companion for the candidate, and in the case of the Mark Master Degree... must supply a Mark Card and Penny with the escort. The escort will also carry a report to be signed by the MEHP or Secretary of the conferring Chapter that the Candidate(s) were present and did received the Degree(s) requested in writing. Chapters conferring the work by Courtesy have no responsibility to report to requesting Chapters, but may do so if they wish.

2014 – 2015 Special Project for Constituent Chapters

Each Chapter is asked to examine the condition of its paraphernalia used in the conferral of all Degrees. Each item used should be clean, well-maintained, safe, and presentable. The MEHP is asked to report

to the Grand Lecturer when the inspection occurs and what the plan is for any repairs or replacement of worn equipment. Not all corrective actions have to be done, but a plan is expected. Special focus is expected for the condition the Obstacles, and the safety of their use in the conferral of each degree. The Grand Lecturer and Deputy Grand Lecturers will be available to respond to questions regarding condition, if there is a question. The condition of all Chapter equipment is ultimately the responsibility of the MEHP, and the improper use of any equipment in worn or unsafe condition is strictly forbidden.

Recommendations for subsequent action the 2015 Semi-Annual Grand Convocation:

Finally, within the body of this report, the Grand Lecturer offers for consideration the following options be granted to the Most Excellent High Priest of each to act upon his discretion as circumstances are appropriate, with action to be determined at the 2015 Semi-Annual Grand Convocation:

1. Cable-tows will be optional, and may be used only if they are in good condition, without wear or deteriorate leather parts.
2. Hoodwinks or blindfolds will be optional in the Royal Arch Degree, and if used each candidate must have one Companion conducting him as he moves about the room until the proper moment when the blindfolds are to be removed.
3. Cable-tows used to lead candidates are no longer appropriate for hoodwinked candidates.
4. The use of swords in the Opening of Chapter, in the MEM Degree, and the RA Degree may be eliminated at the discretion of the MEHP, based on local circumstances and the abilities of the Companions in the Chairs.
5. The General Grand Chapter "Apron Lecture" may be inserted into the Royal Arch Lecture at the point when the Candidates are invested with the Apron.
6. The obstacles in the Royal Arch Degree may be arranged so that the Candidate pass over all three in a single circuit, but all the text of the Ritual must be given before and after each obstacle. Again, the use of this provision would be at the discretion of the MEHP, and based upon the space available in each Chapter Room.
7. The use of the Attitude of Reverence during all Scripture readings, all Prayers, and the attending of the Great Lights shall be a permanent and universal practice of the Grand Chapter of Maryland.

Each Chapter is encouraged to develop a plan to advance its interested Companions through the chairs in each of the degree. The Grand Lecturer and his Assistants will be ready to help whenever the Chapter wants to rehearse and develop their skills.

As all of you know, the General Grand Chapter and all of its subordinate Grand Chapters are supporting research in Central Auditory Processing Disorders (CAPD) through the Royal Arch Research Assistance Foundation. Its work is centered on a research component in CAPD at the University of Connecticut, the Hearing Health Foundation in New York City, and Autism Speaks. I am pleased to report, thanks to the contributions of eleven (11) Royal Arch Chapters in Maryland, our Grand Secretary, Companion Huebschman forwarded one thousand, two hundred and fifty-six dollars twenty two (\$1256.00) to Most Excellent Companion Larry E. Gray, PGGHP, General Grand Secretary. On behalf of our Most Excellent Grand High Priest, I congratulate every Chapter who donated money for this excellent Charity.

In addition, I wish to congratulate Companion Terry Royce and his wife Nancy. Through their hard work, the Southern Maryland York Rite picnic collected four hundred and sixty nine dollars (\$469.00) which was forwarded directly to Autism Speaks.

Goal: To increase membership and participation in local and Grand Bodies by 50% and have competent well trained leaders in management and ritual by 2020.

The initial drop in membership from the 2011 benchmark to the 2012 actual membership was partially due to scrutiny in cleaning up Chapter records and dropping NPD and previously deceased members. We did achieve an increase in 2013 over 2012, but it was less than the targeted 65 per year increase.

Several of the specific strategies in the long range plan have been implemented, such as the standardization of initiation fees for all Chapters and the establishment of a ritual requirement for all Chapters to certify in the Mark Master Degree in 2014.

All Chapters will be required in 2015 to demonstrate that they have maintained proficiency in conferring the Mark Master Degree. In 2016, Chapters will also have to demonstrate proficiency in conferring the Past Master Degree.

This year, the Grand Chapter obtained and distributed copies of “The Peculiar Stone” for use in making presentations to Lodges in addition to the “Fervency and Zeal” program.

The Grand Chapter has also obtained copies of the “Capitular Development Course” developed in New York for adaption to Maryland for the enlightenment and interest of membership as well as development of potential officers at the Chapter and Grand levels.

Remarks of the Incoming Grand High Priest

Companions,

Thank you for your trust and the opportunity to serve you and this Grand Chapter for the upcoming term.

I'd like to start by commenting on something that many of you have heard before, but want to point it out to those who haven't previously attended a function where I have been installed as the presiding officer. When I was raised to the Sublime Degree of Master Mason in October of 1979 in Nanticoke Lodge #172 over on the Eastern Shore, the Worshipful Master stated that it was the Lodge's custom to present a Masonic bible to their newly raised members. He told me that the bible on the altar was mine, and that I could take it after the meeting closed. He also informed me that since I had come through as a single candidate and not part of a class, that they had used that bible on the altar at both of the previous meetings when I had been initiated as an Entered Apprentice and passed to the degree of Fellowcraft; and so, I had taken all three Obligations of masonry on that bible. Since that time, I have used this bible to take the oath of office every time I have been installed as the presiding officer of a masonic or masonic-related body, starting with Grand Commander of the Maryland DeMolay Court of Chevaliers, and including Patron of my Eastern Star Chapter. This has a great deal of significance and meaning for me, and I just wanted to share it with the Companions and guests.

Moving beyond my personal focus, I'd like to share some of the things that the Companions can expect in the upcoming term.

The Grand Chapter adopted the Long Range Plan – and it is my intention to follow it. The Grand Chapter will also work with the other Bodies for their development and adoption, so it will truly be a shared and united York Rite Long Range Plan. Without entering into a lengthy dissertation, I'll touch upon a few points of the Long Range Plan:

Ritual: For 2014, MEGHP Richard Naegle set a requirement that each Chapter must demonstrate proficiency in conferring or exemplifying the Mark Master Degree. For 2015, this requirement is repeated to make sure that now that the Chapters have demonstrated the ability to confer the Mark Master Degree; that they don't lose it. In going forward, the recommendation for 2016 is that the Chapters will again certify on the Mark Master, but also add the Past Master Degree.

Education: The educational program, "The Capitular Development Course", developed by New York under MEGHP Piers Vaughn has been adopted by the General Grand Chapter for adaptation beyond just the Grand Chapter of New York. We were able to obtain copies of the book for this program at the General Grand Triennial, and plan to adapt it for Maryland.

Membership: Under MEGHP Louis Bandell, the "Fervency and Zeal" program was adapted for presentation in Maryland. For the first couple of years, we actively managed it, and were able to

have presentations done at Lodges throughout the State. Once the newness wore off, we shifted our tactics to responding to requests for the program; but those requests have been decreasing. Last year, MEGHP Naegele brought back “The Peculiar Stone” and put out a call for volunteers to learn the parts to establish conferral teams, but there haven’t been many “takers”. This term, we’re going back to active management of these programs – I’ve asked PGHP Naegele to coordinate the recruitment of Companions to learn the various parts of both programs, with the hope that we will be at least two or three deep on each part – that way we should be able to put together a team when needed despite the casts’ conflicting schedules. We will also actively approach Masters and other groups about the possibility of presenting one of these programs instead of waiting for them to ask us.

For an organizational enhancement, I’ve asked Companion Henry McDonald, as the president of the Board of Grand Inspectors, to get together with the Grand Inspectors and put together a Manual, because the role of Grand Inspector for the Chapters is different from what it is for Lodges – for one thing, there isn’t a requirement to take up the “Word”. This Manual doesn’t have to be a huge document; but by taking the best practices of the existing Grand Inspectors, we can share them with all of the Grand Inspectors and standardize what we do. It will also serve as a learning tool and reference for future Grand Inspectors when they are first appointed.

Finally, I wish to express thanks to each of you for being here with us today, and for all your support and service for York Rite Masonry.

And now, there being no further business to come before this Grand Convocation...

By virtue of the power and authority vested in me as the Most Excellent Grand High Priest of Royal Arch Masons of Maryland, and waiving all other forms and ceremonies, I now declare the Grand Chapter of Maryland closed.
