4. Report of the Grand Secretary

MEGHP,

This year has been another of constant adjustments and reconfiguring in our local bodies and in the plans for this Grand Chapter. We have lost planned events but continued to learn & improve upon new communication techniques.

IRS 990N: There is a green banner on the gateway page of yorkritemaryland.org that links to the most expeditious route to the IRS 990N submission page. Several Council Secretaries have already expressed their gratitude for this link in making the process. Easier.

This is one of the many improvements to the **Website**: Most of the inquiries I have for information are answered by the question...did you look on the Grand Chapter Website before you contacted me? The website is a fantastic tool and fountain of information. I commend PGHP William Eppig and MEHP-Elect Rafael Rodriguez for their tireless work in taking my vague suggestions for improvement or innovation...and their own ideas for the betterment of the yorkritemaryland.org website... to make it an excellent tool for our Companions, our Officers, and our visitors.

Annual Reports: The Summary of the Annual Reports for 2020 was submitted in its incomplete state. The returns to the General Grand Council were made based on the prior year's ending figures, per the General Grand Chapter's Constitution, and the appropriate fees paid base on that data. One Chapter is still struggling to reconfigure its administrative services. One Chapter is unlikely to salvage itself but there is always hope.

The School for Secretaries, Recorders, and Treasurers: After losing the 2020 edition of this School for our Administrative Officers, and while laboring under the imposing restrictions for meetings which were different in each Maryland Country, we did hold a very successful School in 2021. Comp. Bill Eppig was given the lead on this project as the Assistant Grand Secretary of the Grand Chapter, and he together with SK Kris Brown, Grand Secretary of the Grand Commandery, and myself devised a meeting agenda. Comp. Eppig arranged with RE Comp John Lister, and MI Comp. John Rafine to develop the individual segments of the School. To add a new degree of accomplishment...Comp. Bill, working with SK Brown converted the School into a virtual event on a ZOOM platform. The attendance was good. The entire event was recorded and is available to any Companion or Sir Knight who would like to watch the content...all four hours which peeled away so fast because it was so engaging. My deepest congratulation to all involved and especially to ME Comp. Eppig.

During the past year, I have been honored to participate in monthly virtual meetings with General Grand Recorder Stephen Balke, and some of the General Officers. This meeting directly conflicts with my duties as Secretary of Druid Chapter, but they have been accommodating in letting me do my presentations early. There have been two interesting developments that have come out

of this personal association with Steve Balke. First, The General Grand Council will emulate our School for Secretaries, Recorders & Treasurers at a Special GG Assembly this coming August, with will be held in conjunction with the Grand Encampments meeting in Minneapolis, MN. The second this that Comp Steve helped facilitate a meeting to explore the use of electronic payment systems for assisting in the financial transactions of the Maryland Grand Bodies...initially with an experimental use for the Grand Sessions Registration on a voluntary basis for those willing, and then with the collection of local body dues and assessment from our local member likewise on a voluntary basis for those willing to participate in an electronic transaction. Those participating in the meeting were equally convinced of the security, and the accuracy of the processes to complete transactions and to place the funds in the desired accounts directly without checks or other paper that can be misplaced on undelivered by the USPS. The great hope I have is to accomplish better service, especially to our newer & younger members, and to lessen the burdens on our administrative officers by participating in this process which consolidates several important actions with direct money transfers.

Finally, a suggestion for better branding of the York Rite. For those locations where it is appropriate, I suggest that they begin styling themselves collectively as The York Rite Bodies of that Locale. Like the York Rite Bodies of Salisbury, Denton, Easton, Germantown, Westminster. Frederick, Glen Burnie, Annapolis, Cumberland, and Camp Springs. As these locations have multiple bodies of roughly the same people. Cockeysville is a bit different and less unified. Hopefully, our potential candidates will begin seeing the same kind of unity they envision as is seen in the Scottish Rite. They will eventually learn the separate but equal character of our three bodies as they improve in their knowledge.

At this time M.E Comp. William Eppig, PGHP was asked to give an update on the website and other IT-related information. (see IT report in section 21 of these proceedings)

Although the report for 2020 shows the year being short \$13,258 in income, due to the market falling when the pandemic hit, we spent \$8,257 less than budgeted and we were able to use cash from the investments to help cover the shortage.

The Interim Report for 2021, as of May 5, 2021, is attached.

Also attached is the 2021 Interim Report for the Trustees Reserve Fund. The report shows the status of the account as of March 31, 2021. The value of the account and its investments as of that date was \$489,128.10.

Also attached as a result of the Accounts and Finance committee meeting is the proposed budget for 2022.

16. Report of Jurisprudence & Constitution

M.E. Comp. Randall L Watson, PGHP

MEGHP and Companions,

One issue has been referred to your Committee on Jurisprudence & Constitution: concerning the status and standing of a Companion who has not fully completed the ritual certification requirements, but is certified by the Grand Lecturer with the understanding that he will complete the ritual presentation for full certification during his term of office, and he is then elected and installed as High Priest of his Chapter; but who then does not further complete the ritual certification to the satisfaction of the Grand Lecturer.

This issue had been addressed several years ago in this, and the other Grand York Rite Bodies, so the Chairman did not have to assemble the full Committee to address the question. Comments on the several aspects are as follows:

Question #1 – The Companion didn't complete his certification in the Work, so shouldn't his installation as High Priest be retroactively considered invalid, therefore he didn't "officially" serve as High Priest?

Article XII - Subordinate Chapters

Section 5: ELECTION AND INSTALLATION OF OFFICERS (May 2016)

- (b) Qualifications for High Priest.
 - (1) To be nominated for election to High Priest of a Chapter of Royal Arch Masons in Maryland, a Companion must have the following qualifications:
 - He must be certified by the Grand Lecturer as meeting the current standards for Ritual proficiency.
 - 1. A Companion must have exemplified the following as the presiding officer, without assistance of written material, and with minimal corrections:
 - i. Opening & Closing of Chapter
 - ii. One of the following combinations:
 - 1) The Mark Master Degree and the Most Excellent Master Degree.
 - 2) The Past Master Degree and the Royal Arch Degree.
 - 3) The Mark Master, Past Master, and either the Principal Sojourner or Captain of the Host in the Royal Arch Degree.
 - 4) Any other pattern of Exemplification will require prior approval and dispensation of the Grand High Priest.

Response #1 – No; there is no provision for a conditional certification for Ritual proficiency. The Grand Lecturer can only certify that a Companion meets the Ritual proficiency certification, or that he does not. Only the MEGHP can issue a dispensation to this requirement. No dispensation was issued, so the Companion has been fully certified by the Grand Lecturer as meeting the current standards for Ritual proficiency.

Question #2 – Is the Companion eligible to be appointed as a Grand Chapter officer?

Article IX – Elections of Grand Officers to be Installed.

Section 3: No Companion can be installed as an officer of this Grand Chapter unless he shall be a High Priest or Past High Priest and at the time a member of some Chapter under this jurisdiction.

Response #2 – Yes; during his first term of office as an installed High Priest, the Companion is eligible to serve as an appointed Grand Chapter officer. He continues to be eligible as a Past High Priest (see the response to question #3).

Question #3 – Is the Companion a Past High Priest once he completes a term of office?

When the Grand Chapter Constitution doesn't address an issue, we go to the Grand Lodge of Maryland's Constitution for guidance.

Grand Lodge Constitution – Article III – Membership of Grand Lodge

Section 1. Membership

The Grand Lodge shall consist of:

D. Past Masters who have presided at least one full term over a Maryland Lodge. A Past Master who has so presided shall be a permanent member of Grand Lodge; and

Response #3 – Yes; once he has completed a term in office, the Companion is a Past High Priest.

Question #4 – Since the Companion has not completed the certification during the first year, must be step out of office or can be be re-elected as High Priest?

STANDING ORDERS AND RESOLUTIONS OF THE GRAND LODGE OF MARYLAND No. 11

6. Any Past Master elected to serve as Worshipful Master for a subsequent term will not be required to be re-certified with their ritualistic work ...

Response #4 – As noted in the response to question #1, the Companion has already been fully certified by the Grand Lecturer, and there is no time limit in the Grand Chapter where the certification expires. Also, under the guidance of the Grand Lodge, a Past High Priest does not have to re-certify in the ritualistic work.

Conclusion:

The underlying point of Law is that the Grand Chapter of Maryland does not have the status or concept of a High Priest who is only "Acting", "Interim" or otherwise serving in some lower classification in a conditional manner – if he is installed to the office, he is a High Priest. Once he serves a full term, he is a Past High Priest and entitled to all the rights and privileges as such, including being a permanent voting member of the Grand Chapter.

Thought long and hard about this presentation and it did not take long for me to realize that the year of 2020 and the restrictions placed on not only us but all of the Masonic bodies throughout the state made a report of this nature impossible to deliver to this body unless I was willing to try a paint an unrealistic picture of how everything will return to normal and how everything will be perfect and throw up a lot of smoke screens and wishful thinking.

Whether we want to admit it or not any long-range thoughts and expectations of this Grand Chapter can and should be tabled until we can fix the short-range situation that we currently find ourselves in. Of the 16 chapters listed in the Grand Chapter Directory:

- How many have actually met over the past year either in person or by zoom?
- 2. How many chapters have provided information to the Grand Chapter website for any activity, degree work, or just general information that they are actually going to have a scheduled meeting? I know that Mt Vernon Chapter does, and I personally thank you for providing this information to all York rite members about the activities of your chapter on the website.
- 3. How many chapters have contacted any of the local lodges to ask for a few moments to speak about York Rite masonry over the past several years? I personally attend many lodges throughout the course of a year for various reasons, but I never pass up an opportunity to ask the worshipful master prior to his meeting if he would allow me to make a few comments about York Rite Masonry.
- 4. How many High Priests have made contact with the Grand Chapter to see if they could provide assistance in helping to prepare their elected officers for the next position? I know that 2 chapters have, and I am personally working with Excellent King Darryl Smith of Tuscan Chapter and Excellent King Lou Romeo of Adoniram Chapter If the chapters will ask, the Grand Chapter will respond.
- 5. But does the Grand Chapter provide an avenue for all chapters to send their officers, for ritual work without them having to ask?
- 6. How many of our York Rite Bodies are willing to allow elected and appointed officers to read out of a book during degree work?

- 7. How many chapters do their best to always open and close in shortened versions and not requiring their officers to learn their work?
- 8. How many chapters provide the local councils with updates as to when a member has received the royal arch degree so that the council can reach out and get this candidate scheduled for the cryptic degrees?
- 9. When the Most Excellent High Priest schedules a visitation how many of us Grand Line Officers actually show up? Difficult for us as an overseeing body to instill in our chapters that we really do care and are concerned for their stability and progress when 2 or 3 officers show up.
- 10. If a chapter called up this Monday and asked the Grand Line to do a Royal Arch Degree how many of the current officers on this Grand Line could actually do the requirements of their stations?
- 11. How many photos are sent to the Grand Chapter after a degree has been done so that all who on could see what is going on in our chapters?
- 12. How often does our Grand Secretary have to spend hours upon hours chasing down information that he should have already received?

I wish that I had the answers to these questions and many more that I did not ask but the status of this subordinate body cannot continue to function in the manner that we are currently working under unless all are held accountable for its future success.

There are many men sitting in this assembly that have seen and been a part of York Rite masonry for many, many years, and I am sure it pains a few of them to see apathy that has begun to settle in and our willingness to just let it happen and just not care.

The chapters of this body need to reevaluate themselves and decide on the stability of their chapter, if they can provide an outlet for master masons to further their Masonic education and if not are they willing to make inquiries into the possibility of a merger thus providing the opportunity of a stronger chapter.

I guess it now becomes time to provide smoke screens and wishful thinking. Next year at this time, hopefully, I will be here providing to this body a report that will include a successful regrowth, a rededication, and re-stabilization on all our parts over the past year and the hope of suggesting a long-range plan or two for posterity.

21. Reports to be Received and Published requiring no action

The IT Modernization Committee has been appointed in order to bring the Grand Chapter of the Royal Arch and the Maryland York Rite bodies up to date in the leverage of readily available technology. The committee is looking at several projects to utilize the available technologies which, once implemented, will place the Maryland York Rite in a position where information can be made available to the individual chapters, as well as the membership, whenever needed.

During the first six months of the appointment of the IT Modernization committee, the work was focused on updating several forms to enhance the communications between the memberships, the individual chapters, and the Grand Chapter. Some of the work included converting the

Petition for the York Rite into a fillable pdf form. Additionally, the Chapter and Council Annual Report Forms were updated and made available online.

The IT Modernization committee continues to work on ways to improve and lessen, to the greatest extent possible, the workloads of the secretaries/recorders. The latest improvement has been to the new petition forms which have been uploaded to the Grand Secretary's/Grand Recorder's pages. The new petition form now consists of three pages, one for each of the York Rite bodies (Chapter, Council & Commandery). The petitioner only needs to enter his personal information on the first page (the Chapter page) and this information gets replicated to the petitions for Council and Commandery. Also, space previously used to manually enter the name of the chapter has been converted to a drop-down selection box. This will allow the petitioner to select the name of the chapter where the petition will be submitted. This selection will then be replicated to the other two pages (Council and Chapter). By making this change, each Royal Arch body has its own copy of the petition for their records.

Another improvement that was made was the creation of a "Petition for Affiliation" form. This new form is also available on the Maryland York Rite website. The Petition for Affiliation follows the same concept as the "Petition for Membership" where the selection of Chapter/Council/Commandery is made by a drop-down selection box. A section was added for companions outside the Maryland Jurisdiction that desire to affiliate to one of the bodies in Maryland.

Finally, the applications for the Council of Anointed High Priest and Thrice Illustrious Master have been converted to fillable forms and are available on the Grand Secretary's and Grand Recorder's sections of the Maryland York Rite website.

The members of the IT Modernization committee respectfully submit this report and request that it be accepted and added to the proceedings of the Semi-Annual Communication of the Grand Chapter of the Royal Arch 2021.
