#### 3. Annual Proceedings

M.E. Comp. William Eppig, Gr. Sec.

M.E.G.H.P.,

The Proceedings of the 2021 Annual Grand Convocation have been available on the Grand Chapter website since November 2021. As the 2021 Proceeding has been available for inspection and review and will continue to be so, I move that they be accepted as posted, subject to further correction should any cause be found.

It was moved and seconded to accept the report, passed unanimously.

### 4. Report of the Grand Secretary P.G.H.P.

M.E. Comp. William C. Eppig,

M.E.G.H.P.,

Being my first year as Grand Secretary, it still has been a learning experience, and I thank all those I have asked for advice over the last six months.

**I.R.S. 990N**: There is a yellow banner on the gateway page of yorkritemaryland.org that links to the most expeditious route to the I.R.S. 990N submission page. Though the I.R.S. requires this form to be completed every two years, The Grand Chapter needs them completed every year. Yearly filing helps prevent a failure to report, primarily if a change in secretaries occurs. If this happens, you may lose your tax status and E.I.N. #.

**Annual Reports**: The Summary of the Annual Reports for 2021 was submitted in its incomplete state. The returns to the General Grand Chapter were made based on the prior year's ending figures, per the General Grand Chapter's Constitution, and the appropriate fees paid based on that data. One Chapter was declared dormant at last year's session, and another has cleared all past fees and has been declared current early this year. The submission deadline is September 30 of each year, but earlier submission is always appreciated. Please double check your addition on the final page, and write separate checks where needed.

**Dormancy:** If financial accounts are not attended to in a three-year period in Maryland, the accounts will be declared dormant, and the funds escheated to the State of Maryland. The funds can be recovered, but this is another unpleasant process. You must visit your institution or have a dialog with your investment officer that constitutes your active management of the money to avoid this situation. Please note that Certificates of Deposit rolling over do not constitute proper attention to the fund.

The School for Secretaries, Recorders, and Treasurers: The 2022 school did not occur due to officer changes and two precentors not being available. We will begin planning a school for 2023.

**Award replenishment:** After an inventory of R.E.D. and WHITE TAUs and G.H.P. AWARDs, we will need to reorder them to have them available for presentation. A quote from the manufacturer has been received, and an order will be placed after the Semi. These awards are a great way to recognize companions that work hard for their chapters.

**Membership Management System:** To update and make membership management easier, not only for the Grand Secretary but also for the Chapter Secretaries. I was given permission to inquire about an external management system. The best know is Grandview, which The Grand Lodge of Maryland uses. Numerous Grand Chapters and Councils also use it.

I contacted Grandview to inquire and get an estimate. The Grand Chapter and Council share the current database, and we like to keep it in one system. Grand View can only provide Two separate systems and at a separate cost for each. However, they have received the same request from others and are working on a system to combine two databases into one system. They will let me know when this is accomplished. The base cost per year would be \$1 per member.

#### 5. Report of the Grand Treasurer

R.E. Comp. John Lister, R.E.G.T.

M.E.G.H.P.,

The report of the Grand Treasurer is that the Grand Chapter is in good financial condition. The Treasurer's Final Report for 2021 is attached. Although the report shows the year being short \$6,792 in income, we spent \$9,001 less than budgeted and stayed in the black. Also attached is the 2021 report of the Trustees Reserve Fund with a balance of \$524,211.

The Interim Treasurers Report for 2022, as of May 10, 2022, is attached, along with the 2022 Interim Report for the Trustees Reserve Fund. The Reserve Fund report shows the status of the account as of April 30, 2022. The value of the account and its investments as of that date was \$487,959.49. It should be noted that in April, the value of our investments dropped \$25,915 or 5%. The geo-political environment and world events have caused a lot of market volatility. One day the NASDAQ had its best day since 2020 and was up 3%, the next day was its worst since 2020, was down 5%. In one day, some of these companies lost billions of dollars, but nothing changed in the fundamentals of these companies, the market will stabilize. The best advice for long term investing is still stay the course.

Also attached because of the Accounts and Finance committee meeting is the proposed budget for 2023.

Annual Conventions The Last Saturday in May A motion was made by Ex Comp Huebschman that this Council of Anointed High Priest coordinate with the Grand Chapter of Royal Arch Masons of Maryland to transfer all funds in the existing M&T checking account to the Grand Chapter's investment account, and that the Secretary/Treasurer shall be authorized to close the M&T checking account at his earliest convenience, and when the funds are made available in a suitable final check, to deposit the balance with THE GRAND CHAPTER of ROYAL ARCH MASONS of MARYLAND, seconded by Ex Comp. Randall L. Watson and passed unanimously.

On October 14, 2021, the Operating Account held at M&T Bank was closed at the Denton Branch, and a Cashier's Check in the amount of \$ 7,933.43 was made payable to the GRAND CHAPTER of ROYAL ARCH MASONS of MARYLAND. The Check was transmitted to the Grand Treasurer RE Comp. John M. Lister for deposit in the Grand Chapter investment funds.

The Ex. President declared a special election open for the office of Treasurer. Ex Secretary Vernon H. Huebschman nominated RE Comp. John M. Lister for the office. There being no further nominations, the M.E. President declared Comp. Lister duly elected and proceeded to install Comp. Lister as Treasurer with full authority to invest all funds, and to pay out such disbursements as voted upon by this Council or later approved by the M.E. President between meetings. The Treasurer then reported that the above-mentioned check was received and deposited, and would now begin accumulating interest and growth in principal as part of the Grand Chapter's fund.

At the Annual Convocation of the Grand Chapter of RAM of M.D., the annual assessment per Chapter paid to this Council of Anointed High Priests was raised from \$30 to \$40 to compensate for the two merging Chapters.

There being no further business to claim the attention of this Council of Anointed High Priests, Most Excellent President Disney closed the Council in due form.
