3. Annual Proceedings

R.E. Comp. William Eppig, Gr. Sec.

M.E.G.H.P.,

The Proceedings of the 2023 Annual Grand Convocation have been available on the Grand Chapter website since November 2023. As the 2023 Proceeding has been available for inspection and review and will continue to be so, I move that they be accepted as posted, subject to further correction should any cause be found.

It was moved and seconded to accept the report, passed unanimously.

4. Report of the Grand Secretary

R.E. Comp. William C. Eppig, G. Sec.

M.E.G.H.P.,

I have a few notes in this report and will touch on them briefly, but the most important thing I need to cover is the new membership management system.

990N: A yellow banner on the gateway page of yorkritemaryland.org links to the most expeditious route to the I.R.S. 990N submission page. Though the I.R.S. requires this form to be completed every two years, The Grand Chapter needs them completed every year. Yearly filing helps prevent a failure to report, primarily if a change in secretaries occurs. If this happens, you may lose your tax status and E.I.N. #.

Ritual Books: Approval was given to reprint the current White Ritual Book at the last meeting. The M.E.G.H.P. took the lead and had 100 New Ritual books printed. They are scheduled to be

picked up this week. We sold the old books for \$15, but with inflation, the cost of printing also went up, so the new price for the Ritual Book will be \$20.

Membership Management System: After some delay and scheduling difficulties with the Membership System administrator. Comp Huebschman and I had a Zoom call with Robert Bigley, the administrator for the System, in late March. While talking with him and his assistant, he informed us the office was moving. This move would have caused a time delay for them to enter the membership data into the System, and it would not have been completed until late fall.

Due to this, we would be allowed to enter the member's date ourselves and have the System up once we were done, so we took that option. They demonstrated how to enter the names, which is somewhat simple, but a little time-consuming.

We reached out to Kris Brown to help, and he agreed. With the three of us working on it, we hoped to have everything entered within a month. After that, we will set up training for those Secretaries and Recorders unfamiliar with the System. We completed entering the data at the end of April, and I would like to thank Comp: Huebschman and Brown for their assistance in entering over a thousand names into this System.

On a good note, by entering the database, we had an adjustment to the bill. It went from over \$4100.00 to \$1500.00.

We entered only the current active membership. We did not enter suspensions or those who died. We will let the secretaries and recorders enter the member if he is reinstated. I will keep the current deaths in the Access file. Any future will be entered into the new System. We ran the names through the GLMMS and found several members that had passed away over the years and not reported, also a few members suspended by the lodge.

We agreed on a process for entering Degree and exaltation dates if we did not have them. This mainly occurred with those members before 1995. Again, we will have the Sec. and Rec. to review and enter if they have it.

After this meeting, an email will be sent to the Secretaries to begin gaining access to the System and their chapter membership. Based on the schedule and location with Wi-Fi, I plan to set up at least three training classes over the next month or two. I want to hold at least three classes north, south, and west in the state. Once training is completed, the general membership will then be given access similar to the GL MMS.

With this new System, the Annual reporting process will change. Since the Secretaries will enter most of the information required on the old annual report form, we only need the tabulation page, 990n copy, and financial information. This year will be a little different than future years and will explain more to the secretaries.

As with any change like this, we expect a one-to-two-year break-in from our old Access system to this new M.M.S. The new System gives the Secretaries and Recorders greater flexibility and instant information at their fingertips.

5. Report of the Grand Treasurer

The report of the Grand Treasurer is that the Grand Chapter is in good financial condition. The Treasurers Final Report for 2023 is attached. Although the report shows the year being short \$2,495 in income, we spent \$12,925 less than budgeted and stayed in the black.

The Semi-Annual Treasurers Report for 2024, as of May 5, 2024, is attached, along with the 2024 Interim Report for the Trustees Reserve Fund. The Reserve Fund report shows the status of the account as of March 31, 2024. The value of the account and its investments as of that date was \$572,744.30, that's a 20% increase since November .1st. This being an election year, often the market does well in the first half of the year. Let's hope this continues in the second half of the year.

Also attached, as reviewed by the Accounts and Finance committee, is the proposed budget for 2025.
