6. Report of the Most Illustrious Grand Master

MIGM William C. Hare

Most Worshipful Grand Master Spicer, Right Puissant General Grand Recorder Irwin, Right Puissant Regional Deputy Grand Master McNorton, Most Illustrious Past Grand Masters, Most Illustrious Guests, Distinguished Guests, Companions. Welcome to the Annual Session of the Grand Council of Royal and Select Masters of Maryland commemorating our 150th year.

The oldest Grand Council of Royal and Select Masters in the world is the Most Puissant Grand Council of Royal and Select Masters of Connecticut, organized on May 18, 1819. Here in Maryland, Royal and Select Degrees were conferred in the Chapters since 1818 and until November 19, 1872, when the Grand Secretary of the Grand Chapter of Royal Arch Masons of Maryland received a certified resolution that was passed prohibiting the Royal and Select Degrees to be conferred in a Royal Arch Chapter.

Concordia Chapter#1, Jerusalem # 2, and Druid#5 formed Concordia, Jerusalem, and Druid Councils (Druid changed its name to Hiram #5 on November 10, 1880). These Councils became the Charter members of the Grand Council of Maryland on May 14, 1874. May 14th, 2024, marked our 150th Anniversary. Hiram Council # 5 Held a Sesquicentennial Festive Board on April 25, 2024, celebrating this 150th Anniversary. I had a commemorating coin celebrating the 150th Anniversary of the establishment of the Grand Council of Royal and Select Masters of Maryland creation made. These coins will be used to help support CMMRF here in Maryland. For a donation of \$25.00, you will receive one of these coins as a gift; all funds collected will be given to CMMRF after production costs are paid.

As far as I know, this year, I also created our first Grand Council pin. The pin is the Grand Seal of the Grand Council, and it shows 1874 as our first year. Please see me if you don't have a pin; I'll be happy to give you one. During my second Cryptic Year, I continued to travel in and out of our jurisdiction, representing our Grand Council of Maryland. Companions during this year, I was asked how many members present were needed to open a Council to conduct business. The ritual book said 9, but nothing was found in the constitution; companions thought you could conduct business with 5. Resolution #17 was passed in 2017 to conduct business. There were 5 Companions needed. This was not recorded in the Constitution causing confusion. I would like to thank the Jurisprudence Committee for correcting this mistake and reentered Resolution #17 as Resolution # 18 correcting this mistake.

I hope that during my two years in this office, I have left the Grand Council better than when I first took office. Thanks to this Grand Council and the Past Grand Masters for all the support you have given me, which has made this job much easier. Thanks to all those Companions who served on my line and all those who supported me through my Masonic Journey. I look forward to supporting this Grand Council and Most Illustrious Grand Master Elect Treklas through the upcoming years. It has been an honor to serve as your Most Illustrious Grand Master.

7. Report of the Grand Recorder

RI Comp. William Eppig, G. Rec.

M.I.G.M.,

I want to thank all the Council Recorders for their dedication and support to their Chapters over the last year, especially with the implementation of the Membership system.

Annual Reports: A summary of the 2024 Annual Reports has been submitted and is on the back of the agenda. All but one Council submitted their reports by the deadline, and all fees have been paid. After the Session, I will submit a final report for Maryland and an assessment to the General Grand Council in November.

We are officially using the new Masonic Membership Solutions database, which has been open to the secretaries since June. Most Recorders have been adapting to it, but a few are still getting used to it. One advantage of the system is that we were able to shorten the Annual Report submitted to the Grand Council from 15 pages to just 3. They can utilize the annual report from the MMS but must delete any plural members from the count so as not to pay an assessment for them since the home council is responsible for that.

Another advantage is that we now have a more accurate membership count for the Grand Council of Maryland, with the Council and Grand Council databases being almost identical.

Last year, the chapters reported 852 members, but the Grand Council had close to 1000 members listed. As reported by the chapters, we have 817 members. This is a deduction of 35 after the conversion. This is slightly off from the Grand Council by 11, and I believe it is due to the council not removing plural members from their totals as requested in the directions.

By using the new MMS, we can have our Dues cards printed by the same company that prints the Commandery and Scottish Rite dues cards. They are more professional-looking and can be mailed using a window envelope instead of the Recorder taking the time to address an envelope to send the card to the member.

The Dues cards for all the councils have been printed and are at the desk for the recorder or representative to pick up after this meeting. The company includes a printout of the chapter membership on which the cards are based.

I encourage all recorders who are here, as well as any Thrice Ill. Grand Masters and elected line, to review the provided dues card member list and make any necessary corrections. Membership systems only work as well as the information inputted into the system. We started well and will only get better.

The system is also open for each member to view their profile and have the ability to adjust or add information as needed. And I encourage them to do so.

The next item on the agenda is to cross-reference lodge deaths and suspensions with ours and notify the Grand Commandery of those individuals.

All donations from our Council to Cryptic Masons Medical Research Foundation have been mailed to the Foundation.

Secretary and Recorder School: I am considering holding a Secretary / Recorder School in February 2025. We have had several changes over the last year which should benefit them. Plus, we can refresh on the MMS.

Rituals: In May, we voted to print a new Council Rituals by the end of the year. I have not heard any updates.

Working with you over the last two years was a pleasure, Most Illustrious, Grand Master. Your dedication to this Grand Council is exemplary. You have left a legacy that future MIGM can look back on. Congratulations on an outstanding two years!

8. Report of the Grand Treasurer

M.I. Comp. John A. Rafine

Most Illustrious Grand Master William Hare,

The treasury of this Grand Council is financially sound. I consulted with our Financial Planner and received the following information about our account activity.

“The Royal & Select Masters portfolio, which has a growth objective, was inceptioned at the very end of the Federal Reserve’s interest rate tightening policy, with the last rate hike in July of 2023. Short-term interest rates continued to rise into October of 2023, when the Federal Reserve hinted that it may not raise interest rates further. The bond market started to price in Federal Reserve rate cuts and the 10-year treasury yield dropped from 5% to as low as 3.9% by year end. This created a very nice tailwind to the return of the portfolio, as it was comprised of approximately 20% of fixed income.

The stock portion of the portfolio contains a diversified mix of large, medium and small cap stocks and is much more diversified than the S&P 500. 10 of the 500 stocks in the S&P 500 have driven about 90% of the return of the index over the last year and a half, and we are just now starting to see some of the other equity asset classes produce positive returns. Small companies, which tend to out-perform when borrowing costs are low, should continue to rise as interest rates

continue to drop. Dividend paying stocks, should also provide positive returns as they compete less with high yielding short-term interest rates.

By examining the report I prepared, you may note that over \$7,000 of the returns since inception came from the income produce from the portfolio, whereas \$30,000 of the return came from market appreciation of both stock and bond investments. The 12 month return of the portfolio since 9/30/2023 was 24.74% net of expenses which compares to the S&P 500 of 36.35%. The bond aggregate index returned 11.5%.”

Our increase for the period of 11/01/2023 through 09/30/24 was \$52,457.06, an increase of 28.85%.
