Secondly, I have been working on problems with the Constitution and Resolutions and trying to clear up mistakes and admissions of text. A few of you will hear from the Committee reports tonight. In the interest of time, I will sum up My past two years in my report at the Annual in Ocean City, several issues I will address in my report tonight.

### 7. Report of the Grand Recorder

RI Comp. William Eppig, G. Rec.

M.I.G.M.,

I have a few notes in this report and will touch on them briefly, but the most important thing I need to cover is the new membership management system.

**990N:** A yellow banner on the gateway page of yorkritemaryland.org links to the most expeditious route to the I.R.S. 990N submission page. Though the I.R.S. requires this form to be completed every two years, The Grand Council needs them completed every year. Yearly filing helps prevent a failure to report, primarily if a change in secretaries occurs. If this happens, you may lose your tax status and E.I.N. #.

**Membership Management System:** After some delay and scheduling difficulties with the Membership System administrator. Comp Huebschman and I had a Zoom call with Robert Bigley, the administrator for the System, in late March. While talking with him and his assistant, he informed us the office was moving. This move would have caused a time delay for them to enter the membership data into the System, and it would not have been completed until late fall.

Due to this, we would be allowed to enter the member's date ourselves and have the System up once we were done, so we took that option. They demonstrated how to enter the names, which is somewhat simple, but a little time-consuming.

We reached out to Kris Brown to help, and he agreed. With the three of us working on it, we hoped to have everything entered within a month. After that, we will set up training for those Secretaries and Recorders unfamiliar with the System. We completed entering the data at the end of April, and I would like to thank Comp: Huebschman and Brown for their assistance in entering over a thousand names into this System.

On a good note, by entering the database, we had an adjustment to the bill. It went from over \$4100.00 to \$1500.00. The Council Cost was about \$700.00.

We entered only the current active membership. We did not enter suspensions or those who died. We will let the secretaries and recorders enter the member if he is reinstated. I will keep the current deaths in the Access file. Any future deaths will be entered into the new System. We ran the names through the G.L.M.M.S. and found several members who had passed away over the years and not been reported, as well as a few members suspended by the lodge.

We agreed on a process for entering Degree and Greeting dates if we did not have them. This mainly occurred with those members before 1995. Again, we will have the Sec. and Rec. to review and enter if they have it.

An email was sent to the Recorder to begin gaining access to the System and their Council membership. Based on the schedule and location with Wi-Fi, I plan to set up at least three training classes over the next month or two. We wanted to hold at least three classes north, south, and

west in the state, but everyone felt we should do a Zoom meeting. We will schedule a Zoom meeting After June 10<sup>th</sup>. The System will be under maintenance as they move the office. Once training is completed, the general membership will then be given access similar to the G.L. M.M.S.

With this new System, the Annual reporting process will change. Since the Secretaries will enter most of the information required on the old annual report form, we only need the tabulation page, 990n copy, and financial information. This year will be a little different than future years and will explain more to the secretaries.

As with any change like this, we expect a one-to-two-year break-in from our old Access system to this new M.M.S. The new System gives the Secretaries and Recorders greater flexibility and instant information at their fingertips.

### 8. Report of the Grand Treasurer

Most Illustrious Grand Master William Hare,

The treasury of this Grand Council is financially sound. Fusco Associates periodically reallocates our investment accounts to react to market changes and informs me about the changes and reasons for doing so. Our 2023 operating expenses totaled \$ 24,727.31, which was \$1,766.62 under budget.

The U.S. stock market enjoyed a strong first quarter in 2024, advancing 10%. The S&P fell by - 4.08% in April, but April's decrease has been offset by May's increase as of May 15, 2024.

For the period of November 1, 2023, through April 30, 2024, our investment account value increased \$29,591.95, a 16% gain. Our investment account balances for April 30, 2024, and the three previous years were:

### 15. Jurisprudence and Constitution

The Jurisprudence Committee appreciates the opportunity to serve the Grand Council Royal and Select Masters of Maryland. One item was assigned to this committee for review. In 2017, a resolution was approved to allow Maryland Councils to open and conduct business with 5 Council members present. Proceedings for 2017 were not available on the website and the adopted standing resolution was not added to our Grand Constitution. To remedy this situation, the approved 2017 standing resolution is being added to our Grand Constitution as Standing Resolution 18. Existing Standing Resolution 18 was renumbered to Standing Resolution 19 to maintain continuity with our existing Resolution date adopted numbering sequence.

Standing Resolution 18 reads as follows:

RESOLVED, "That a constituent Maryland Council may assemble on the occasion of a Stated Assembly with five or more Companions of that Council, and with that as a sufficient number, conduct any normal business relevant to that Council.

If dispensation is granted by the Most Illustrious Grand Master which includes language to permit conduct of business at a Special Assembly, a Council may also conduct its normal business at a Special Assembly, as above, provided due notice is provided for the Special Assembly.

Normal business shall include election of candidates, reading and approving minutes, reception and payment of bills." - May 16, 2017

Standing Resolution 18 does not alter the requirement of having nine council members in attendance to confer the degrees. The Most Illustrious Grand Master along with the Ritual Committee will determine what, if any, changes are required to our existing Ritual for opening a Council.

During our Grand Council Semi-Annual Assembly on May 23, 2024, the following actions were motioned, voted and unanimously approved.

- Created an ad-hoc "History Committee" with M.I.G.M. William Hare appointed Grand Historian.
- Reprint 100 rituals cost to be determined
- Amend the 2024 budget to our current membership number (to be provided) for income line number A "Per Capita" and expense line item 7, "Per Capita General Grand" and make the necessary adjustment in Income Line item E (Transfer from Investments) to balance the budget
- Approval to spend up to \$700 to purchase 100 coins commemorating our 150<sup>th</sup> anniversary and making the necessary adjustment to our 2024 budget

Merkle Monuments informed us that after holding its engraving costs for many years, it had to increase its engraving cost from \$45 to \$50 per brick. Revisions were made to the Walk of Remembrance Brick Order form and a fillable form was posted to the Grand Lodge website.

For 2023, the Grand Lodge ordered 27 bricks for its Grand Line Officers, and the Order of the Eastern Star recently ordered 8 bricks. Brick engraving for these bricks will be completed after Memorial Day, and the Grand Lodge of Maryland will be invoiced after the engraving is completed.

We need to do a better job announcing the availability of bricks for Masons in Maryland. Many Blue Lodges are visited each January, and we request that those presenting Worshipful Master pins mention the availability of bricks during their visit.

Bricks are available for many occasions such as recognition of outgoing Worshipful Masters, York Rite and Scottish Rite officers and members, deceased members, etc. Each brick currently costs \$60, and checks should be made payable to the Grand Council R.S.M. of Maryland and annotating the memo field Walk of Remembrance.

We recommend adding the brick order to our YorkRiteMaryland website.

We receive \$10 per brick designated for charitable purposes, which is equally divided between Grand Lodge and the Grand Council. We have not withdrawn any funds for the past several years and hope to generate sufficient sales to warrant a withdrawal.

The M.I.G.M. asked R.I. Comp. Spyridon G. Treklas for remarks following his election:

I want to express my gratitude for electing me as the Most Illustrious Grand Master for the upcoming term. As I mentioned during our recent semi-annual Conclave, I am open to discussing opportunities. I believe that having no idea is a bad idea. Please feel free to reach out to me, and let's explore how we can implement your ideas. I firmly believe that there is no such thing as "we've never done that before" or "we tried that before and failed." Instead, when faced with new ideas, our response should be, "Great, let's try something new," and when revisiting past failed attempts, our response should be, "Great, let's analyze what happened and figure out how we can improve it this time."

During our official visits to your Council, I have certain expectations for the Council Officers:

- **1. Council Plans** I would like to see the current Thrice Illustrious Master (T.I.M.) working with the Deputy Illustrious Master (D.I.M.) and the Principal Conductor of Works (P.C.W.) to develop a three-year plan for your Council. This plan should outline the future of your Council and detail strategies to improve membership and attendance. Remember, it's better to have a plan that fails than to fail to plan.
- **2. Membership Companion** Every Council should have a Membership Companion. If your Council does not have one, please appoint someone to this role. Our ranks are dwindling, and it's crucial to have a plan to attract new members. The Membership Companion, in collaboration with the Council's plan, should work towards achieving positive growth for your Council. The Illustrious Principal Conductor of Works Elect, Stephen R. Twomey II, will lead the Membership Committee at the state level.
- **3. C.M.M.R.F. Companion** Each Council should also have a C.M.M.R.F. Companion. If your Council does not have one, please appoint someone to this role, and it should preferably not be the same Companion as the Membership Companion. The local C.M.M.R.F. Companion will work alongside our Maryland C.M.M.R.F. Chairman, Right Illustrious Deputy Grand Master-Elect Andrew Martinez, to support C.M.M.R.F. initiatives at the local level. With the cooperation of the C.M.M.R.F. Chairman and the C.M.M.R.F. Companion in your Council, I believe our state can lead in this area.
- **4. Ritualist Companion** Every Council should designate a Ritualist Companion. If your Council does not have one, please appoint someone to this role, and it should preferably not be the same Companion as any of the above. When we visit your Council, I expect to see the Opening of the

Council performed from memory, without the assistance of the ritual book. I encourage Councils to commit the opening to memory before our visit.

**5.** Checking Account – Going forward, I expect every Council to have its own checking account and to manage its own expenses. Any checks received by the Grand Council from a Council should be in the name of the Council, whether it's for the Council's assessment or for any other purpose. Even though we are part of the York Rite and share the same building, each Council is an individual body, just like the Chapter and Commandery.

I want to reiterate that we are here to listen and support you as we move forward together.
